Subject : Representation against the overall assessment/remark by
Hon'ble Administrative Judge, Kaushambi for the year
2020-2021.

Respected Sir,

It is humbly submitted that I was posted as Additional
District & Sessions Judge/ Additional Judge (POCSO Act Court)/
Special Judge (N.D.P.S. Act), Kaushambi during the year 2020-2021.

In the annual assessment, the Ld. District Judge rated
me as an "outstanding officer". However, the Hon'ble High
Court/Administrative Judge has rated me as "Good Officer" after the
overall assessment. I most humbly submit my representation against
the overall assessment/remark by the Hon'ble Administrative Judge
from "good" to "outstanding" or as deemed fit by the Hon'ble High
Court.

My submissions are as under :-

1. The Ld. District Judge has rated me as an "outstanding
officer" after the overall assessment for the year 2020-2021 on
30.06.2021.
2. However, the Hon'ble High Court/Administrative Judge has
reduced the grading from "Outstanding" to "Good" after the overall
assessment on 04.12.2021 assigning no reasons for the same.
3. A brief description of duties performed by me during the
relevant period is as under :-
 - (i) Additional Judge (POCSO)/ Special Judge (N.D.P.S.)
 - (ii) Officer In-charge Nazarat, Kaushambi.
 - (iii) Officer In-charge Telephone, Kaushambi
 - (iv) Member, Administrative Committee.
 - (v) Member, Finance Committee.
 - (vi) Member, Grievance Committee.



4. In the remarks given by the Ld. District Judge it has been mentioned that the officer is punctual and regular in sitting on dias in Court during Court hours. His behaviour towards women is courteous. The officer is Courteous, disciplined, obedient and laborious.

5. During the relevant period, i.e. 2020-2021 I have decided 06 Sessions Trials, 03 Criminal Revisions, 07 Criminal Misc. cases, 09 final Reports and 01 POCSO Act Case.

6. During the relevant period, the target units required were 603.52. The units achieved were 425. My output was 70.42%. The target units could not be achieved during the assessment year inspite of best efforts being made as Covid - 19 guidelines were in place and evidence was not being recorded in the court and only urgent matters were being taken up for most of the period. This fact has been taken into account by the Ld. District Judge in the Overall assessment. Further, the Hon'ble Administrative Judge has also recorded that "the disposal of the officer is 70.42%. The explanation given by the officer is plausible that due to Covid - 19 guidelines only urgent matters were being taken up."

7. It is submitted that during the previous year, i.e. 2019-2020 against the target units of 691.60, I had given 1001.69 units and my output was 144.83%. On an overall assessment, the Hon'ble Administrative Judge had rated me as an officer of outstanding merits.

In view of the above, it is most humbly prayed that my matter be placed before the Hon'ble High Court for upgrading my assessment from "good" to "outstanding" or as deemed fit by the Hon'ble High Court. It is humbly submitted that I apologise for the delay in submitting the representation and pray to the Hon'ble High Court for condoning the delay. I shall be highly thankful to the Hon'ble Court.
