Subject: Representation against the adverse remarks given in Column Nos.1(c),1(d), 2. and 4.given in my Annual Confidential Report,2021-2022, by Sri Ravi Nath, then the respected District Judge, Deoria.

Respected Sir,

With reference to abovementioned subject matter, it is submitted with all humality that my humbel submissions against advers remarks given by Sri Ravi Nath, then the respected District judge, Deoria are as follows:

1. With regard to adverse remark given in column No. 1(c), that I am not cool minded and lose temper in court. It is kindly submitted that there is no complaint against me either by any Advocates or public, nor there has been even oral or written suggestion during the year to me by then respected District Judge in this regard. I am unable to find the reason for such observation. Moreover, in column no. 1(i) , my relation with bar is shown 'cordial' by then respected District Judge.

2. With regard to adverse remark given in Column No, 1(d), that adverse report had come to Sri Ravi Nath, then the respected District Judge, Deoria that I lose temper with members of staff and junior officer.

It is humbly submitted that, first the qustion in column no.1 (d) does not relates to the remark given by then the respected District Judge as it pertains to my private character in relation to pulic and its adverse affect to my discharge of official duty. Secondly, to the my best of knowledge, I have never shown such behavior to any staff or any junior officer nor there has been any complaint, written or oral, either from staff or junior officer.

Moreover, in column no. 01(h), my control over office and my administrative capacity and tact is assessed 'good'. And in column no. 01(j), my behavior in relation to brother officer is assessed 'good' by then the respected District Judge,

3. With regard to adverse remark given in column no. 4, as again observed by Sri Ravi Nath, then respected District Judge, Deoria that I am short tempered and have no regard for the respected District Judge and my subordinate judicial officer and loses temper with staff.

Again, it is kindly submitted that no such kind of behaviour had ever been showed by me. I also do not know that how then respected District Judge, Deoria perceived me to disregarding him or other judicial officer. Moreover, in column no. 01(m), then respected District Judge, Deoria finds me amenable to the advice of the District Judge and other superior officers.

4. With regard to adverse remark given in column no, 2 by then the respected District Judge that my overall assessment is 'poor' It is humbly submitted that it is not clear that how he assessed my overall performance as poor. I do not find any reasonable ground for such overall assessment. I pray before the Hon'ble Court that my overall assessment be modified on the basis of my performance as to my judicial and administrative work.

Lastly, it is with all humility, it is submitted before the Hon'ble Court that Sri Ravi Nath, the then respected District Judge, Deoria had also been my District Judge, Deoria in 2020 – 2021 and then also he gave me adverse remarks with regard to my 'loose temperament' without any basis. Barring these last two years, in 21 years of my service, I have never got any adverse entry while five of my then respected District Judges had been elevated to Hon'ble Court.

Hence, it is most humbly prayed that my representation be placed before the Hon'ble Court for merciful consideration and adverse remarks, as being without any basis, be expunged.
