Subject:- Representation against Annual Confidential Remarks recorded by the learned District and Sessions Judge, Unnao, for the year 2021-2022

Sir,

It is submitted most respectfully that I am working in the cadre of Civil Judge, Junior Division at Unnao since 15.11.2019.

Learned District and Sessions Judge, Unnao, has recorded my Annual Confidential Remarks for the year 2021-2022 on 08.05.2022 in respect of which, I want to bring the following facts for kind consideration of Hon'ble High Court:

1. That during the above period (01.04.2021 to 31.03.2022), I had presided over the Court of Additional Civil Judge, Junior Division, Court No.2, Unnao, from 01.04.2021 to 12.08.2021 and presided over the Court of Judicial Magistrate, Unnao, from 13.08.2021 to 31.03.2022.
2. That the remarks recorded by the learned District and Sessions Judge in column No.01 (e) (iii) show that I had decided **18** cases which were more than **05 years old** and **17** cases which were more than **10 years old** but it appears that inadvertently it

has been so recorded because as a matter of fact, I had disposed of 05 civil cases and 52 criminal cases and in total 57 cases which were more than 05 years old and 08 civil cases and 48 criminal cases and in total 56 cases, which were more than 10 years old.

Yearwise, details of disposal of cases which were more than 05 years and 10 years old, are as under:

**More than 05 years old cases:**

04/2015, 01/2016 = 05 Civil Suits

10/2013, 12/2014, 08/2015, 08/2016 and 14/2021 = 52 Criminal Cases

**More than 10 years old cases:**

03/2003, 01/2004, 02/2005, 01/2010, 01/2012 = 08 Civil Suits

01/1989, 03/1990, 02/1991, 03/1992, 01/1994, 01/1995,  
01/1996, 02/1997, 03/1998, 02/1999, 03/2000, 03/2001,  
03/2002, 03/2003, 02/2004, 02/2005, 03/2006, 03/2007,

01/2008, 04/2009, 01/2010, 01/2011 = 48 Criminal Cases

3. That the remarks recorded by the learned District and Sessions Judge in column No.01 (e) (v) show Nill interim applications disposed of by me notwithstanding that I had disposed of 13 **interim injunction applications** during the said period.
4. That the remarks recorded by the learned District and Sessions Judge in column No.01 (g) (i) show that 40 cases were decided by me after full contest notwithstanding the fact that I had decided 40 criminal cases and 01 Small Cause Suit after full contest.



5. That the remarks recorded by the learned District and Sessions Judge in column No.01 (g) (iii) reflect that I had disposed of only **03** cases in Lok Adalat notwithstanding the fact that I had disposed of **623** cases in Lok Adalat and this fact was duly mentioned by me in column No.16 of the Self- Assessment Form Part 01.
6. That the remarks recorded by the learned District and Sessions Judge in column No.01 (e) (iv) reflect that I had not disposed of any execution case.

In this respect, it is most respectfully submitted that I had presided over the Court of Additional Civil Judge, Junior Division, Court No.2, Unnao, from 01.04.2021 till 12.08.2021. During this period, only 18 execution cases were pending in that Court. During this period, from 20.06.2021 to 30.06.2021 and from 03.07.2021 to 12.08.2021, I had availed of earned leave. From 01.06.2021 to 30.06.2021, civil work was suspended in compliance of Orders of Hon'ble High Court. From 01.04.2021 to 31.05.2021, due to pandemic COVID-19, in compliance of orders of Hon'ble High Court and the learned District and Sessions Judge, only most urgent cases and limited work was taken up in the Courts. Judicial Officers were directed to attend the Courts on rotation basis.

In the above facts and circumstances, I could not dispose of any execution case.




In light of above facts and circumstances and the quantum of work done by me, who is a new entrant in the Judicial Service, which is about **594% (Required only 100% without stenographer)** as per requirement norms fixed by the Hon'ble High Court, it is most humbly submitted that my whole work may kindly be taken into account because remarks of overall assessment as 'Good' appears to have been recorded by the learned District and Sessions Judge, Unnao, under the mistaken belief of my not disposing the quantum of work as was actually and factually disposed of by me.

It is further submitted that in the light of quantum of disposal at my end, the upgradation of the remarks may kindly be looked into and if somehow or the other, the upgradation of the remarks is not deemed fit and justified, my request may kindly be considered for setting the record straight.

It is most humbly implored that my representation may kindly be placed before the Hon'ble High Court for kind and sympathetic consideration.
