In addition to this I was posted in outlying court mehrouni where internet connectivity is very low or nonexistent due to which I could not check online and got to know about the same on 06.07.2022 when I came to headquarter I am representing against the same before the Hon,ble Court within one month from my Knowledge. Therefore it is humbly requested to Hon,ble Court to kindly condone the delay, if any delay is caused in representing against the Annual Confidential Remark for the year 2021-2022.

- 3. That the respected District Judge has been pleased to assess me as overall average on the basis of Assessment submitted by me to him.
- 4. That the respected District Judge has found my integrity beyond doubt.
- 5. That the respected District Judge has found me as a fair and impartial officer in dealing with Public and bar.
- 6. That the respected District Judge has found me as cool minded and does not lose temper in the Court.
- 7. That the respected District Judge has not found my private character is such as to lower me in the estimation of the public and adversely affects the discharge of my official duties.
- 8. That the respected District Judge has obeserved that my fixation of cause list was proper and I have fixed sufficient number of cases to keep me engaged during full court hours and have avoided unnecessary adjourtments.
- 9. That i have disposed total 220 cases in the year 2021-2022 out of which 01 case of the year 2000, 01 cases of the year 2005, 08 cases of the year 2011, 12 cases of the year 2012, 13 cases of the year 2013, 14 cases of the year 2014, 12 cases of the year 2015, 08 cases of the year 2016, 48 cases of the year 2017, 28 cases of the year 2018, 29 cases of the year 2019, 33 cases of the year 2020, 04 cases of the year 2021 and 02 Execution and 8 Misc. - 14. That the Respected District Judge observed that my judgments on facts and law are on the whole sound, well reasoned and expressed in good language. The Respected District Judge has also observed that my marshalling of facts are good, my appreciation of evidences and applicability of law is proper.
- 15. That in said relevent year 2021-2022, i was not provided with stenographer. Despite of that I have achieved total 1376.35 Units(i.e.269.13%) against required 511.28 units for the whole year included that period of closure of courts or the normal functioning of the courts has been kept in abeyance due to pandemic covid-19 which has not been found indequate by the respected District Judge.

My humble submission is that I am totally amenable to the advice of respected district judge and superior officers. Any oral or written communication was not recieved by me on behalf of respected district judge in this regard neither any warning was given. It appears that due to some misunderstanding respected district judge has observed that.
- 19. That the respected District Judge is of opinion that double quota has been claimed regarding bail and misc. Work. Hon, ble sir bail has been typed unfortunately by clerk in place of statement recorded in Court (Bayan) and I came to know about this after uploading and same was communicated to steno of respected District Judge.
- 20. That the respected District Judge is of opinion that I made full and effective regular inspection of my office, court and various

departments as an in-charge officers.

- 21. That the respected District Judge was of opinion that I was punctual and regular in sitting on dias in Court during Court hours.
- 22. That the respected District Judge has found my behavior towards women (respect and sensitivity exhibited towards them) was good.
- 23. That the respected District Judge has found my Marshalling of facts proper, appreciation of evidence proper, application of law proper, disposal of work is that is 269.12% without stenographer, behavior towards brother officers is cordial, punctual in Court.
- 24. That the respected District Judge has of opinion that effective control on office, not so tactful and not passesses proper administrative Control. Respeced Sir Court is parent Court (Filing Court) and aaprox 2700 cases and there is only 1 Clerk, who come to Court Mehroni From District Head Quarter Lalitpur. Which is approx 45 Km away .Clerk has only 4 to 5 years of experience . I was not communicated ever in this regard.
- 25. That despite of aforesaid good opinion the respected District Judge has been pleased to assess me average in the said ACR.
- 26. That if in ACR. As of average assessment is allowed to remain in existence, it may cause irrepairable loss to me.
- 27. That in view of above facts and circumstances, the Hon'ble Court is requested kindly to upgrade my Annual Confidential Remarks for the year 2021-2022.
