Subject: Representation against the only adverse remark regarding disposal of lesser contested cases during the Assessment Year 2021-22 as recorded by Shri Devendra Singh-I, Learned District Judge, Mahoba.

Sir,

I most respectfully beg to submit my representation on the subject noted above as under:

1. That I belong to the 2018 batch of Civil Judges (Junior Division) and joined my judicial service as Judicial Magistrate-I, Mahoba on 16.11.2019 and thereafter underwent my foundation level training conducted by the Institute of Judicial Training & Research, Uttar Pradesh, Lucknow for one year and started doing actual judicial work in my Court at Mahoba from the month of September, 2020. Pandemic Covid-19 had quite adversely affected the entire functioning of the courts during those days.
2. That during the Assessment Year 2021-22, I was posted as Judicial Magistrate-II, Mahoba from 01.04.2021 to 28.06.2021 and thereafter was transferred from the head quarter to the out lying court at Charkhari, Mahoba and since then I am posted at Charkhari as Civil Judge (Junior Division)/ Judicial Magistrate, Charkhari, Mahoba till date.
3. That the learned District Judge, Mahoba has recorded following appreciative entries in my ACR for the Assessment Year 2021-22

except that I had decided lesser number of contested cases during the said assessment year 2021-22:

"integrity-beyond doubt, fair & impartial in dealing with the public & bar, cool minded, there was nothing adverse against my private character, fixing of cause list-proper, sufficient number of cases fixed to keep engaged during full court hours, unnecessary adjournments avoided, judgments on facts and law-sound and well reasoned and expressed in good language, marshalling of facts-proper, appreciation of evidence-proper, application of law-proper, 02 execution cases decided after full satisfaction, total work done 1416.32 Units against the prescribed 1008.41 Units i.e. 131.14% which is adequate and above the norms, used to grant or refuse interim orders & injunctions for sufficient reasons, control over the office and administrative capacity & tact-good, relation with members of Bar-good, behaviour in relation to brother officers-good, inspections of court & office-full & effective, punctual and regular in sitting on dias during court hours, amenable to the advice of the District Judge & other superior officers, behaviour towards women, respect and sensitivity exhibited towards them-good, state of health-normal, overall assessment of the officer-"Good".

4. That the only adverse remark recorded by the said learned District Judge, Mahoba against me in the Assessment Year 2021-22 is that I had decided only 01 original suit and 14 criminal cases as contested during the whole year.
5. That as has been recorded by the learned District Judge himself under paragraph 01(g) of my ACR, I had achieved 1416.32 Units against the prescribed 1008.41 Units towards the work done during the said assessment year which is 131.14% and the same is adequate and above the norms. I had thus done more work than required under the relevant circular letters and the learned District Judge himself has recorded that the work done by me during the said assessment year was adequate and above the prescribed norms. In view of the fact that I had done more than normally required judicial work from me, no adverse comments could have been made by the learned District Judge on the quantum of work done by me.
6. That it is most humbly submitted that in my out lying court at Charkhari, I had to deal with both the civil and criminal cases

including the remand, bail and other urgent criminal works as well as the civil works besides the overall administrative management over the staff and affairs of the said out lying court at Charkhari and even then I had given more than required disposal during the said assessment year as has also been recognized by the learned District Judge himself in my ACR. As regards the possibility of disposal of more cases during the relevant assessment year, it is humbly submitted that I got myself throughout busy in hearing and deciding the civil and criminal cases in my court at Charkhari and was always regular and punctual in sitting in my court and this fact has been duly recognized by the learned District Judge himself in columns number 01(e)(i)(b), 01(k) & 01(l) of my ACR. Most of the cases in my court were got ripen by me but by the end of the assessment year i.e. 31.03.2022 the same could not be finally decided for various reasons including pandemic Covid-19, non-cooperation of lawyers, non-appointment of Stenographer in my court except for 13 days in the month of July-2021 and similar other factors. Still I gave more than required percentage of quantum of work during the said assessment year.

7. It is, therefore, most humbly prayed that your goodself may kindly place this representation of mine before the then Hon'ble Administrative Judge of the District Court, Mahoba for His Lordship's kind consideration. It is further prayed that the Hon'ble Court may be pleased to kindly consider this representation of mine and make my proper assessment by expunging the aforesaid only adverse remark on the point of disposal of lesser number of cases as recorded by the learned District Judge, Mahoba in my ACR for the Assessment Year 2021-22. I shall remain grateful to the Hon'ble Court for this grace throughout my life.
