What criteria has been adopted to award the Grade in ACR is not clear as there have not been any adverse remarks mentioned in ACR regarding my conduct, behavior or any short comings in my judicial work. There is no justification or reason of any kind given as to when the total unit achieved by me is more than prescribed quota then why the entered grade in ACR is merely "Good"? It reflects that the grade awarded in ACR is totally biased, discriminatory, selective in nature and an affecting factor to my career and future prospects which creates an unhealthy environment lowering down the moral and working efficiency of the undersigned.
