

Subject: Regarding Representation against remarks in Annual Confidential Remarks for the year (2021-22)

Respected Sir,

With due respect, I have the honour to submit before the Hon'ble Court with regard to the Annual Confidential Remarks for the Year 2021-22 which are as follows:

1. That in the relevant year 2021-22 I held the following courts:
 - (a) Additional Civil Judge (JD), Meerut from 01/04/2021 to 15/07/2021
 - (b) Civil Judge (JD)/FTC(CAW), Meerut from 15/07/2021 to 31/03/2022
2. That the Annual Confidential Remarks for the year 2021-22 has been filled by the Respected District Judge on 02/07/2022 on e-services portal for Judicial Officers. I am representing against the same within one month of filling of ACR by the Respected District Judge.
3. That the Respected District Judge has been pleased to assess me as "Good" on the basis of self assessment submitted by me to him.
4. That the Respected District Judge has certified my integrity and found it to be "Beyond Doubt..
5. That the Respected District Judge has found me fair and impartial in dealing with the Public & Bar.
6. That the Respected District Judge has found me as cool minded and does not lose temper in Court.
7. That the Respected District Judge has not found my private character is such as



to lower me in the estimation of the public & adversely affects the discharge of my official duties.

8. That the Respected District Judge has observed that my fixation of cause list was proper & I have fixed sufficient number of cases to keep me engaged during full Court hours and have avoided unnecessary adjournments.
9. In point number 01 (e)(iii) of ACR regarding Disposal of old cases , The District Judge has mentioned that there is Nil Contested cases. But During my tenure of Civil Judge (JD) (CAW) I have decided:

Contested DV Act Cases : 4 cases
Contested State Cases : 3 cases { Year 2009, 2017, 2017}
Total : 7 Cases

10. In point number 01 (e)(iv) of ACR regarding Progress and disposal of execution cases , The District Judge has mentioned that there is NIL execution cases. But during my tenure of Additional Civil Judge (JD), Meerut, {01-04-2021 to 15-07-2021}, there was no pending execution in the court and Covid guidelines, passed by Hon'ble High Court , were prevailing during that period also.
11. That the Respected District Judge has observed that my Judgements on facts and on law are on the whole sound, well reasoned & expressed in good language. That the Respected District Judge has also observed that my marshalling of facts is good, my appreciation of evidences and applicability of law is proper.
12. That in the said relevant year 2021-22 I have achieved Total 1071.20 Units i.e. 210% against required 509.54 Units for the whole year including the period of closure of Courts or the Normal/ Regular functioning of the Courts kept in abeyance due to pandemic Covid-19. Which has not been found inadequate by the Respected District Judge.
13. That I have decided 06 cases wherein all witnesses of fact turned hostile & case ended in aquittal and I have decided 709 cases in Lok Adalat.
14. That the Respected District Judge is of opinion that my control over the office, my Administrative capacity & tact was good.
15. That the Respected District Judge has found my relations with members of BAR & Brother officers were good and I was amenable to the advice of



Respected District Judge & other superior Officers.

16. That the Respected District Judge is of opinion that I made full & effective regular inspections of my office, Court & of various departments as an in-charge Officer.
17. That the Respected District Judge is of opinion that I was punctual & regular in sitting on dais in Court during court hours.
18. That despite of aforesaid good opinion the Respected District Judge has been pleased to assess me 'Good' in the said Annual Confidential Remarks.
19. That in regard to "Other Remarks made by Respected District Judge I have already provided clarification/explanation in the relevant points above.
20. That if the above Annual Confidential Remarks as 'Good' & 'Other Remarks made by Respected District Judge is allowed to remain in existence it may cause irreparable loss to me.
21. That in view of above 'Facts & Circumstances' the Hon'ble Court is requested kindly to upgrade Annual Confidential Remarks for the year 2021-22 and washout/amend the "Other Remarks' if deemed just & proper and oblige.

You are therefore requested kindly to move the Hon'ble Court for favorable & Kind consideration and oblige.
