**SUB: REPRESENTATION FOR PROPER ASSESSMENT OF ACR ENTRY

Respected Sir,

I most respectfully beg to submit my representation on the subject noted above as under-

I have been posted in the District Court, Deoria since 22.08.2019 as Additional District & Sessions Judge. My ACR for the assessment year 2021-2022 has been recorded by the then learned District Judge Sh. Ravi Nath.


Learned District judge has observed in column no. 01(e)(iii) Disposal of **Old Cases** (Give number and year of old cases decided) as "31 CASES", whereas I have decided 38 old cases which includes 31 of "More than 5 year old cases" and 7 of "More than 10 year old cases". The details of these criminal and civil cases were annexed in proforma attached with the self assessment.

Learned District judge has observed in point 01(e)(iv) regarding progress and disposal of **Execution Cases** as "NA" whereas I have decided 8 executions in full satisfaction and have furnished the details. The said cases are mentioned in the contested civil cases. It is apposite to submit here that some of these execution cases were more than 5 years old which was decided by the undersigned in full satisfaction.

Learned District judge has observed in column no.1(g) (i), number of cases decided after actual full contest as "16 criminal cases and 10 civil cases after full contest" whereas the undersigned has decided 49 Criminal Cases and 36 Civil Cases after full contest. Details of the disposal of the civil and criminal cases are attached with the self assessment.

Learned District judge has observed in column no.1(g) (iii), "NIL" disposal through **compromise/alternate dispute resolution** whereas the undersigned has disposed of 98 cases in National Lok Adalat.

In column 1(f) regarding the judgments, though the learned District Judge has observed that judgments on facts and law, on whole are reasoned and that the



Appreciation of evidence and law is satisfactory but has observed that the judgments are in Hindi language. It is respectfully submitted that the judgments of the undersigned are in English language and a copy of the judgments attached with the self assessment.

It is respectfully submitted that despite the extraordinary situation arisen due to pandemic, I still managed to achieve more than the prescribed quota. The undersigned most humbly wishes to bring to your kind notice that in the year 2021-22 the work done by the undersigned was 1702.69 which is substantially more than the prescribed quota in spite of the fact that the Courts were not fully functional due to COVID-19 pandemic and only urgent matters such as bail/remand were taken up and later on when the Court started functioning normally, it also took some time for work to resume to normal for recording of evidences and hearing of cases.


It is respectfully submitted that I was not issued any D.O. by the then learned District Judge, for my behavior, conduct, Judicial work or administrative work. Neither did he indicate otherwise also, as to where and on what criteria outside the prescribed parameters set in the format, I was falling short.

I most respectfully pray to His Lordship to kindly make my proper assessment for the Assessment Year 2021-22. I shall remain grateful to His Lordship for his grace forever.
