**SUB:REPRESENTATION SEEKING EXPUNGING OF THE REMARKS
GIVEN IN COLUMN NO. 4 REGARDING HEALTH CONDITION AND FOR
PROPER REASSESSMENT OF THE ACR ENTRY FOR THE ASSESSMENT
YEAR 2021-22**

Respected Sir,

In reference to the above mentioned subject matter, with due respect it is most respectfully submitted that :

I have been posted in the District Court, Deoria since 16.11.2019 as Addl. Civil Judge (JD). My ACR for the assessment year 2021-2022 has been recorded by the then learned District Judge Sh. Ravi Nath.

Learned District Judge has observed in Column No.1(g) (i), --- No. of cases decided after actual full contested- N.A. criminal cases and 3 civil cases after full contest whereas, the undersigned has disposed off total 3 cases after full contest which includes 2 criminal cases and 1 civil case.

Learned District Judge has observed in Column No.1(g)(iii),--- Nil disposal through compromise/alternate dispute resolution whereas the undersigned has disposed off total 65 cases (4 civil and 61 criminal cases) in National Lok Adalat/by way of ADR.

Learned District Judge, in Column No. 4 has remarked that "Not good. She falls sick quite often. She needs to take proper care of her health" whereas in Column No.3, he himself has given the general condition of health as "Good" which is contrary to his own remark. It is most respectfully submitted that the undersigned has not availed any medical leave for the assessment year 2021-22. As such, the remarks given by the then learned District Judge is without any basis.

Learned District Judge, in Column No. 2 has assessed the overall performance of the undersigned as "Good". It is respectfully submitted that the undersigned has never derelicted from her duty. Despite the extraordinary situation arisen due to pandemic, the undersigned managed to achieve more than the prescribed quota. It is respectfully submitted that for the year 2021-22 the work done by the undersigned was 1353.81 which is substantially more than the prescribed quota in spite of the fact that the Courts were not fully functional due to COVID-19 pandemic and that the undersigned was not provided any stenographer.

It is further respectfully submitted that I was not issued any D.O. by the then learned District Judge, for my behaviour, conduct or judicial work.

In view of the above facts and circumstances, the remark regarding the health of the undersigned recorded in Column No 4 by the then learned District Judge is baseless and not sustainable and is liable to be expunged.

I request therefore to your goodself to place this representation of mine before the Hon'ble Administrative Judge of District Court, Deoria for His Lordship's kind consideration. I most respectfully pray to His Lordship to kindly expunge the remarks made in Column No. 4 recorded by the learned District Judge, Deoria in my ACR entry for the assessment year 2021-22 and to reassess the overall performance in Column No 2 in my ACR entry for the assessment year 2021-22.

I shall remain grateful to His Lordship for his grace forever.
