In the annual remarks 2021-2022 the Ld. DJ Mr. Rajat Singh Jain  
while assessing my work has in columns

I would like to mention that I was holding the Court of Special  
Judge Exclusive POCSO and hence I was not having any pendency of  
execution cases and Civil cases in my Court. The same had been  
especially mentioned in the statements attached along with self  
assessment.

Hence these columns were not applicable to me and instead of  
passing the remarks of "not applicable" the learned DJ Meerut Mr. Rajat  
Singh Jain has wrongly denoted the remark of NIL which gives the  
impression that I have not done any execution cases and Civil cases by  
compromise/ADR when actually, the fact is that there was no pendency  
of execution cases and Civil cases in my Court.

I would also like to mention that on the criminal side I have  
decided 22 cases in the Lok Adalat.

Lordship I would like to point out that in my entire service none of the District Judges who have assessed my work have ever found me lacking on these two points mentioned about.

Moreover in my tenure at Meerut since 2019 I was assessed by erstwhile DJ's who have found me to be cool minded and my relation with the bar have been "Good", "Balanced" and Cordial.

The learned DJ Mr. Rajat Singh Jain joined Meerut on 24.11.2021 and has assessed my work for the financial year 2021-2022.

In assessing my work he has been District Judge for a period of four month's and six days only and without any cause has passed the adverse remarks "Needs Improvement" and "Improvement would be Good".

My earlier District Judge Mr. Dinesh Kumar Sharma during his tenure never apprised me of any short-coming on my part. The bar at Meerut has never complained against me, but the present DJ Meerut Mr. Rajat Singh Jain has without any cause and holding a biased view against, me for reasons best known to himself, has passed these adverse remarks.


