

OFFICE OF THE DISTRICT JUDGE, RAMABAI NAGAR (KANPUR DEHAT)**ORDER**

In compliance of Hon'ble Court's letter no. 1944/LXXXVII-CPC/e-Courts/Allahabad dated 14.04.2021, regarding Guidelines for functioning of District Courts, keeping in view the increasing cases of COVID-19 in Districts, the Nodal Officer (Computer) is hereby directed to create a dedicated email of the District Court and the details of the same be published on the website of District Court. The above email may be used for receiving the Bail/Anticipatory Bail Applications or other urgent applications and these applications sent by the Learned Counsels through email shall contain the details of Advocate/Litigants including his mobile number, email ID.

The Computer Section shall download such applications received through email and necessary list shall be generated.

The Judicial Service Centre (Centralised filing Counter) shall be used for receiving fresh cases/applications (Civil/Criminal) from the Advocates/Litigants/other stakeholders. All such cases/applications shall be registered in CIS. The applications/cases shall contain the details of advocate/litigants including their mobile number. The defects if any, may be informed to Counsel Concerned.

The Computer Section shall also inform about the functioning of eCourts app. to all the Ld. Counsels approaching the Judicial Service Centre so that they can view the listed matters/cause list through the above app.

The Nodal Officer Computer shall ensure the updation of cases in CIS and Court proceeding through Video Conferencing with the assistance of System Officer, System Assistant, Technical Man Power and other staff members deputed in the Computer Section of the District Court.

It is hereby directed to Nodal Officer (Computer) that a dedicated helpline for assisting the advocate/litigants mentioning the Landline/Mobile Numbers shall be published on the District Court website and be circulated for any information regarding the mechanism of listing of cases in cause list and time slot etc.

It is hereby directed to Nodal Officer (Computer) that he shall ensure that the Video-conferencing link be shared with the Learned Counsels/Prosecution by the Judicial Officer concerned for conducting the Court proceedings. The Learned Counsels and prosecution may join for court proceedings through Video conferencing. (As per the link provided by the concerned Judicial Officer).
