## **ORDER**

In compliance of Hon'ble Court's letter no. 1983/LXXXVII-CPC/e-Courts/Allahabad dated 20.07.2021, whereby in supersession of all earlier guidelines regarding opening & functioning of District Courts during the period of lockdown and thereafter, new guidelines have been issued for functioning of District Courts with effect from 22.07.2021. Following instructions are issued in view of the above letter issued by the Hon'ble High Court for the functioning & working of Courts:-

- 1. All the Courts/Offices of Kanpur Dehat Judgeship shall open to take up Judicial work and Administrative matters w.e.f. 22.07.2021, as per existing provisions, rules, guidelines and circulars issued from time to time.
- 2. All Judicial Officers are hereby directed to ensure that minimum number of parties/counsel present in the Court Room at one time for Court proceeding alongwith physical distancing guidelines.
- 3. During the course of physical hearing, learned Advocates would adhere to the COVID-19 protocol, and accordingly will wear face mask/cover and keep social and physical distancing.
- 4. Any type of COVID-19 pandemic situation reported by the District Administration/C.M.O., the District Court/Outlying Court may be closed for the said period and information for the same with reason an intimation shall be sent to the Hon'ble High Court.
- 5. Thermal scanning checkup of all person entering in the court premises shall also be ensured with the help of District Magistrate, other offices & CMO/CMS.
- 6. Frequent sanitization of the premises of District Court, common facilities and all points, which come into human contact viz. door-knobs, chairs, tables etc. will be ensured with the help of District Administration.
- 7. The District Court, Kanpur Dehat and Outlying Courts of Kanpur Dehat Judgeship shall remain closed on Saturdays and Sundays as per the guideline issued by the State Government as per the resolution of the Hon'ble High Court dated 22.04.2021. During the said period, the Court premises shall be completely sanitized.

All the directions/instructions issued by the Hon'ble High Court be followed in terms of Hon'ble Court's letter no.

The Nodal Officer (Computer) & System Officer are hereby directed to upload the copy of this order on official website of District Court, Kanpur Dehat. The Secretary, DLSA is also directed to publicize this order in the local print & electronic media.

A letter be sent to the District Magistrate/C.M.O. & C.M.S. for sanitization of the Court premises and Thermal Scanning etc. The Officer In-charge (Nazarat) is directed to ensure sanitization of the Court premises and Thermal Scanning etc. strictly in accordance with the guideline issued by the Hon'ble High Court vide letter no. 1983/LXXXVII-CPC/e-Courts/Allahabad dated 20.07.2021 on daily basis.
