ORDER

In compliance of Hon'ble Court's letter no. 1944/LXXXVII-CPC/e-Courts/Allahabad dated 14.04.2021, regarding Guidelines for functioning of District Courts keeping in view the increasing cases of COVID-19 in Districts, the Hon'ble Court has communicated the guidelines as under:-

The Judicial Officers shall undertake the following nature of matters through the physical mode/by way of video conferencing and as soon as their court work is completed, they shall leave the court premises.

- a) Pending/Fresh Bail Applications.
- b) Pending and Fresh Anticipatory Bail Applications.
- c) Disposal of Misc. urgent Criminal Applications.
- d) Disposal of urgent Civil Applications such as Injunction matters.
- e) The Judicial work/Remand in respect of under trial Prisoner.
- f) All such Cases/ matters where Hon'ble Courts have issued directions for expeditious disposal, in a time bound manner.
- g) Any other nature of matter, which is urgent or appropriate.

It is hereby directed that only 4 chairs will be arranged in courtroom for advocates with proper distance. Mask shall be used by everyone who enters the courtroom and the Court Staff i.e. Reader, Clerk etc. shall follow Social/Physical distancing guidelines. Only such Learned Advocates, Litigants should come to Court premises, whose cases/matters are listed and as soon as the court work is completed, Ld. Counsels & Court Staff shall leave the Court premises.

As per the directions of Hon'ble Court, the Secretary District Legal Services Authority, Kanpur Dehat shall render necessary assistance for generating awareness amongst the stakeholders regarding the Court working through electronic mode and the same needs to be popularized by the way of pamphlets, Media coverage and other modes. The necessary assistance of paralegal volunteers may be taken.

The Administrative officer and Central Nazir of District Court, Kanpur Dehat shall ensure minimal entry of Court Staff in court premises which will not be more than 50% of the working strength.


