Subject: Submission of representation against adverse remark and ACR Entry awarded by the then District Judge Barabanki Shri Radhey Shyam Yadav for the Assessment Year 2021-22

Sir,

With all due humility undersigned, wishes to make the following submissions before you that:

- 1. Undersigned is judicial officer batch of 2018 Uttar Pradesh Judicial Services, she joined as Civil Judge (Junior Division) on 16/12/2019 at District Court Barabanki. Undersigned has thus so far completed barely 03 years in Judicial Service.
- During the Assessment Year 2021-22 then District Judge Barabanki Shri Radhey Shyam Yadav has recorded my Annual Confidential Remark for the Assessment Year 2021-22 wherein my overall assessment assessed by him is – "Good".
- 3. The District Judge Barabanki has certified my integrity and has given the undersigned generally good entries under every column.
- 4. The only one adverse remark recorded by the Ld. District Judge in Column no. 01 (g)(i) is quoted as under: Number of cases decided after actual full contest; "01". Whereas in the column 14 of the Annual Confidential Report undersigned has clearly mentioned that 9 Warrant Cases (Contested) were decided during the Assessment Year 2021-22.
- 5. During the Assessment Year 2021-22 as per the work done by the undersigned, overall achieved 926.69 units against the target units of 350.56 units (percentage 264.15 %). Undersigned has decided 9 cases after actual full contest, 08 cases decided on compromises, 1 ex-parte Judgment of Domestic Violence Act, 1 uncontested execution cases, 26 cases decided in Lok Adalat, and decided 1 oldest case also. The undersigned has worked hard to dispose of the above-mentioned numbers of cases.
- 6. It is also brought to your kind notice that during the relevant Assessment year, the undersigned has performed civil work only for 12 days (i.e. 01/04/2021 to 12/04/2021) as Civil Judge (Junior Division) FTC in Court no 39 at Barabanki, and after that undersigned performed only criminal work as Civil Judge (Junior

Division) FTC (Crime Against Women)/ Judicial Magistrate Court no 43 at Barabanki. This is the prime reason that undersigned has disposed of only one civil execution case during the Assessment Year 2021-22.

7. The overall assessment has been made without assigning any reason. The then District Judge Barabanki has not assessed my work properly and meticulously.

In light of the aforesaid facts, it is most humbly requested that my letter be placed before the Hon'ble Court with the profuse prayer to kindly modify the aforesaid adverse remark recorded by then Ld. District Judge, Barabanki from my ACR for the Assessment Year 2021-22 and the entry of the undersigned may be ameliorated.
