2020-2021 recorded by Hon'ble Administrative Judge  
Sessions Division Firozabad.

**Sir,**

1- I have the honour to submit that I was posted as Civil Judge (Senior Division) Firozabad in the year 2020-2021 (hereinafter referred to as the year under assessment). The then district Judge, Firozabad had recorded the following remarks which were adverse-

1-(a) Integrity of the officer- Whether beyond doubt, doubtful or positively lacking- Note- If the officer's integrity is doubtful or positively lacking, it may be so stated with all relevant fact reason (s) & supporting material.	Doubtful, several complaints from bar regarding corruption have been received. Numerous transfer applications were also moved against him alleging extraneous consideration. I tried to make her change here attitude but all in vain. Several warnings and demy officials letters were also served but no improvement has been seen.
2- Over all assessment of the merit of the officer (Out Standing. Very good, good, Average, poor)	Average.

2- When I had moved representation against the aforsaid remarks, the Hon'ble Administrative Judge, Sessions Division Firozabad has upgraded my over all assessment as "very good" from average, but the column of integrity has been left over blank for the year under assessment.

The remarks, recorded by the then Hon'ble Administrative Judge, Firozabad are as under.

3- The Hon'ble Administrative Judge, has agreed with the recommendation made by the learned District Judge Firozabad. Over all Assessment has been upgraded very good for average. The Hon'ble Administrative Judge has not mentioned any thing regarding my integrity. Since, the remark/recommendations recored by learned District judge, Firozabad in columns No 1 (a) are adverse, hence the remarks recorded by the Hon'ble Administrative Judge or omission in the column of integrity I.e. 1(a) shall also be deemed to be adverse.

4- I want to draw the kind attention of the Hon'ble Court / committee towards the remarks recorded by Learned District Judge, Firozabad in column No. 01 (a) which relates to the integrity of the officer. The Learned District Judge has recorded my integrity as doubtful, but the Learned District Judge has not mentioned the supporting material regarding my Integrity, even a single complaint in writing from the Bar or the litigents regarding corruption has not been received to the respected District Judge, Firozabad during the year under assessment (from 01-04-2020 to 31-03-2021). Neither the copy of any complaint/letter was furnished to me by the Learned District Judge, Firozabad, nor any demi official letter/warning letter was served upon me during the year assessment. No copy of demi official letter/letter or complaint has been attached with the remarks as supporting material regarding my integrity. So far as the question of moving numerous transfer applications is concerned, in that regard I have to submit that transfer applications were moved by the learned counsel to get the order passed in their favour against law. Transfer applications were moved to make pressure upon the Court. Mere moving some transfer applications does not make my integrity doubtful. I have completed my judicial service of more than 06 years till the end of year under assessment. Before the remarks recorded by Learned District Judge, Firozabad, no other District Judge has recorded my integrity as doubtful. All the District Judges except the present District Judge, Firozabad, has certified my integrity as beyond doubt.

5- If these adverse remarks remain as they are, these remarks will adversely affect my future Judicial career. My future Judicial career

totally depends upon the kind hands of the Hon'ble Court/ committee.

I, therefore, humbly request you to kindly place my representation before the Hon'ble Court/committee for sympathetic consideration to expunge the remarks recorded in column No. 01 (a) by the Hon'ble Administrative Judge Sessions Division, Firozabad for the year under assessment i.e. 2020-2021.

I shall be highly thankful to the Hon'ble Court for its kind consideration in this regard.
