Respected Sir,

It is most respectfully submitted as under-

1. That the undersigned was posted as additional district & Session Judge court no. 04/special judge E.C.Act since 01.04.2021 to 12.04.2021 and Adj court no.07/u.p. gangster and anti social activities (prevention) act since 13.04.2021 to 31.03.2022 in Kanpur Nagar and the A.C.R. of the applicant is recorded by the respected district judge Kanpur Nagar for the year 2021-2022 and inform by the Id. district judge in June 2022.
2. That the Id. district Judge has certified the integrity of the applicant 'Beyond doubt' And also mentioned in column 01 (f) that the judgement passed by the officer on facts and law are sound, well reasoned and expressed in good language and in column 01 (g) clearly mentioned that the officer has achieved the target of 1666.23 Units against target of 609.60 units. It being 273.33 %, where in column 01 (f) (i to iii) that marshalling of fact, appreciation of evidences and application of law are proper. If the judgements are whole sound, well reasoned and expressed in good language then marshalling of the fact, appreciation of evidences and application of law should be good but the Id. district judge has only mentioned it 'proper', this remark of entry may effect the judicial career of the applicant.
3. That in column 01 (e) (iii) the Id. district judge has mentioned that applicant has disposed of the old cases as-1/92, 1/93, 2/94, 4/95, 4/96, 9/97, 4/98, 12/99, 6/00, 6/01, 7/02, 3/03, 3/04, 3/05, 7/06, 2/07, 2/08, 10/09, 6/10, 1/13, 12/16 and in column 01 (g) (i) that applicant has decided 127 cases after actual full contest.

Applicant has decided 12 s.s.t. pending more than 25 years, 38 s.s.t. pending more than 20 years and 43 s.s.t. pending more than 10 years, 18 session trial cases on merit. The applicant has decided maximum number of oldest cases. Applicant has also decided 01 rent appeal, 01 s.c.c. revision, civil revision and mise. Appeals along with 08 Execution cases. Applicant has decided total 389 s.s.t as contested and 81 s.s.t. otherwise during the assessment period.



4. That the applicant has done his judicial work with honesty and devotion. Besides the adverse situation were occurred due to covid -19 pandemic. when courts came properly functional applicant has achieved the excess work quota 2256 units from 1 april 2021 to 31 march 2022.
5. That the applicant was also cordinated in administrative work and was chairman of finance committee where applicant has work sincerely and solved the financial matters of staff.
6. That the applicant has performed his judicial work with honesty and integrity with utmost devotion and decided maximum number of old cases, cases of under trial prisoners and senior citizens. Applicant has also decided civil and execution cases. The assessment of the officer should be based on his work and conduct. The Id. district judge has recorded that the officer has cordial relation with brother officers and members of the bar and control over the office and punctual in sitting on dias and also behaviour is good and sensitive towards women but the Id. district judge has assessed 'good' only. If the entry of the applicant is upgraded it would be helpful for the career and also encourage me to do best work in future.


It is therefore applicant most humbly request you to put the representation before the honourable court for kind consideration and most humbly begs to honourable court to upgrade the over all assessment in column 02 and 01 (f) (i to iii) of the A.C.R. of applicant.
