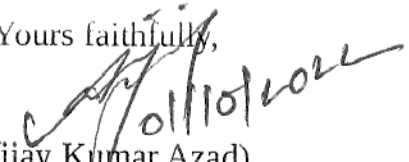
The copy of these remarks are also being submitted/attached here with for kind perusal and ready reference of the Hon'ble Court.
