Sub: Representation against Annual Character role, recorded by District & Sessions Judge, Kanpur Nagar for the year 2022 – 2023

Respected Sir,

With regard to Hon'ble Court, my representation against ACR 2022 – 2023, is as below –

1. Hon'ble District Judge, Kanpur Nagar, in his remark, given in above ACR 2022–2023, has written nothing adverse against my work, conduct and integrity. My control over the files, disposal of execution cases, rating of quality of Judgment, my control over office and administrative capacity, relationship with Bar, Judicial fraternity, amenability with Senior Officers advice, respect to woman has been rated to be '**Good and satisfactory**'. Overall assessment is of a '**Good officer**'.

2. My representation is limited to the Column No - 4 i.e. "**Other remarks if any**", wherein, it has been mentioned –

"As per the Action Plan the officer was expected to decide 30 oldest Original Suits & 10 oldest execution cases, but the officer has decided- 29/30 oldest Original Suits & 4/10 oldest execution case . As per the Action Plan, the officer has decided less Original Suits and Execution Cases. The officer was presiding over a parent Civil Court with plenty of work, but still the officer has not decided the desired number of cases under the Action Plan. With greater experience and effort the officer will certainly decide more cases in future".

3. My disposal of old cases with number and year of its pendency was given in Column No. – 01(e)(iii) "No of 5 year old cases disposed- 271, No of 10 year old cases disposed 281, Original Suit- 1/1993, 1/2003, 1/2010, 2/2011, 1/2012, Misc. Civil Case- 3/2011, 1/2014, 2/2016, 5/2017, Execution Case- 1/1987, 1/2007,1/2017". But, this was not taken under consideration. As per unit system, my achievement was 2790 units as against 1200 targeted. It was more than double of the prescribed standard. Even in remark column disposal of 29 old year cases against expected 30 has been written, i.e. 01 less in number. 26 execution cases were decided and it was written in Column – 01(e) (iv) by learned DJ itself.

4. With regard to shortfall in Action Plan 2022-2023, it is being mentioned that presiding officer has tried best for lawful disposal of these files. The efforts and endeavor of the

presiding officer to make the files of old execution cases get matured have not been considered and respected District Judge has passed remark in ACR which may damage the judicial carrier of the officer.

5. With all pertinency to Hon'ble District Judge and profound regard, respect to Hon'ble Court it is being mentioned that the working scenario of Kanpur Nagar Judgeship was perturbed after joining of the then, District Judge, Kanpur Nagar, because of frequent resistance, abstinence from work, strike and boycott by Civil Court Staff, Members of Bar as well as other stake holders. I worked with all my devotion, capacity and sincerity, even then got this remark, which is factually not substantiated, which may damage Judicial carrier.

6. Hon'ble Court is being prayed for deleting above adverse remark. Hon'ble Court is further being solicited to rate me in Upper Degree than a 'Good officer'. I shall be indebted forever.

7. Your Honour is being requested to place my representation before Hon'ble Court for kind and sympathetic consideration, prayed as above.
