Subject : Representation with regard to Annual Confidential Remarks for the Assessment Year 2022 -2023 recorded by the Learned District Judge, Kanpur Nagar

Respected Sir,

With regard to Hon'ble Court, my representation against Annual Confidential Remarks 2022-2023 is as below :-

1. The then Respected District Judge, Kanpur Nagar in his remark, given in Annual Confidential Remarks 2022-2023 has written nothing adverse against my work, conduct and integrity. My control over office and administrative capacity, relationship with Bar, Judicial fraternity, amenability with Senior Officers advice, respect to woman has been rated to the '**Good and Satisfactory**'. Overall assessment is of a '**Good Officer**'.

2. My representation is limited to the Column No – 4 i.e 'Others remarks if any', wherein, It has been mentioned -

“As per the action plan the officer was expected to decide 9 oldest inquiries as Principal Magistrate of J.J.B., 20 oldest cases (other than miscellaneous cases) as A.C.M.M., 5 oldest original suit, 2 oldest execution cases as Civil Judge (Sr. Div), but the officer has decided 01/05 oldest original suit as Civil Judge (Sr. Div). The officer has not decided any oldest inquiry as Principal Magistrate of J.J.B., any oldest cases (other than miscellaneous cases) as A.C.M.M. and has also not decided any oldest execution cases as Civil Judge (Sr. Div), but the officer has made efforts for deciding them.

3. Sir, I have been holding three court under the assessment year 2022-2023 i.e as Principal Magistrate of J.J.B., Kanpur Nagar from 01.04.2022 to 10.07.2022, as Additional Chief Metropolitan Magistrate Court No 1, Kanpur Nagar from 10.07.2022 to 03.02.2023 and as Civil Judge (Sr. Div), Kanpur Nagar from 03.02.2023 to 31.03.2023.

4. Sir, It is humbly submitted that I have submitted statement showing disposal of cases which are more than 10 Years old cases of all the above mentioned three courts, in which as Principal Magistrate of J.J.B I have disposed 15 cases which are more than 10 years old. As Principal Magistrate of J.J.B I have disposed 1 case of year 1998, 2 cases of year 2003 and 1 case of year 2005. It clearly reveals that I have disposed 4 oldest cases from 1998 to 2005.

5. My disposal of old cases with number and year of its pendency was given in Column No 1(e)(iii) of Annual Confidential Remark 2022-2023 “ No. of 5 year old cases disposed – 135, No. of 10 year old cases disposed – 67. In the same column It is mentioned that No. of old case disposed as 1/1978, 1/1984, 1/1989, 2/1990, 1/1992, 2/1993, 3/1995, 2/1996, 1/1997, 2/1998, 2/2000, 2/2001, 2/2002, 3/2003, 4/2004, 2/2005. It clearly shows that from year 1978 to year 2005 I have decided 31 oldest case. It is also respectfully requested the the said disposal of 31 cases related to the Court of Additional Chief Metropolitan Magistrate Court No 1, Kanpur Nagar only and not included the disposal cases of Juvenile Justice Board, Kanpur Nagar and Civil Judge (Sr. Div), Kanpur Nagar.

6. Sir, It is humbly requested that I have been assigned criminal work 10 Months out of 12 Months under the Assessment year 2022-2023 and I have disposed 35 case from the year 1978 to 2005. As Criminal Court I had to disposed 35 case. Old cases with number and year of its pendency was given in Column No. 1(e)(iii) of Annual Confidential Remark 2022-2023 clearly shows that I have disposed 31 case from the year 1978 to 2005 but In remark may be due to oversight by the then Learned District Judge, Kanpur Nagar It has been written that I have not decided any oldest case as Principal Magistrate of J.J.B and Additional Chief Metropolitan Magistrate Court which is against the statement submitted by me. Hon'ble Court is being prayed to expunge/delete the said remark as the present remark may damage the Judicial career of the Officer.

7. Sir, It is humbly submitted that I have worked as Civil Judge (Sr. Div), Kanpur Nagar from 03.02.2023 to 31.03.2023. During this short period I have disposed oldest Original Suit of year 1971 and 1 Execution Case of the year 2017. It is humbly submitted that during the month of March 2023 working scenerio of Kanpur Nagar Judgship perturbed due to bycott and Strike by Lawyers'. During this short period I have made positive efforts for deciding the oldest case and oldest execution case. I also wish to submitt that my actual required unit was 780.16 but I achieved 1505.85 unit which is approx 193%. Hon'ble Court is being prayed to consider the same.

8. Hon'ble Court is being prayed for deleting above adverse remark. Hon'ble Court is further being solocited to rate me in Upper Degree than a 'Good Officer'. I shall be indebted forever.

9. Your Honour is being requested to place my representation before Hon'ble Court for kind and sympathetic consideration, prayed as above.
