I have the honour to submit that I have joined in Judicial Services on 23.03.2001. I have submitted my self assessment statement for the duration of 01.04.2022 to 31.03.2023, when I was posted at Varanasi. The Respected District Judge has rated me as overall assessment as "**Average**". The undersigned wants to crave the permission to request your goodself and also wants to attract the kind attention of your goodself towards the problems and the hardships which the undersigned is facing as the same will definitely be aggrieved due to the above described rating. The following points which the undersigned is describing as under:-

1. In column no. 01 (f) "**Whether judgment on facts and on law are on the whole sound, well- reasoned and expressed in good language**" - Respected District Judge has mentioned as "**Yes**"

Column no. 01 (f) (i) Marshalling of facts, Colum no. 01 (f) (ii) Appreciation of evidences and Column no. 01 (f) (iii) Application of law, In all the three colums of 01 (f) : Respected District Judge has mentioned as "**Average**".

I have the honour to submit that if Respected District Judge has given "**Yes**" in column no. 01 (f) then how it is possible that in all the sub colums of 01 (f) are "**Average**".

2. I have to say that the disposal achieved during assessment period 01.04.2022 to 31.03.2023 is **1947.87 units** against 1200 units, which comes to **162.32 %**. In my achievements, I have decided 35 oldest




cases, in which one of the oldest case was Civil Appeal of 1979. I have decided 11 execution cases in Lok Adalats and 39 cases, which was fully contested has been decided. The Respected District Judge/ Assessing Officer mentioned in colum no. 4 -"The Officer has decided many old cases"

3. During my assessment period 2021-2022 the same Respected District Judge had given overall assessment as "Very Good" and regarding Marshalling of facts, Appreciation of evidences & Application of law, Respected District Judge/ Assessing Officer rating as "Good".
4. During my service around 23 years in Judiciary, I have never been awarded adverse remark by the Appellate Court/ Respected District Judge/ Assessing Officer on my judgments or any comments related to it. I am unable to understand that why the Respected District Judge/ Assessing Officer rating as "Average".

It is therefore humbly pray to the Hon'ble Court to consider the facts as mentioned the above and to upgrade my ratings as assessed by Respected District Judge, Varanasi. Kindly place before the Hon'ble Court for kind perusal.
