Sub: Representation against the remarks given by the then District Judge, Kanpur Nagar for the assessment year 2022-23 (01.04.2022-31.03.2023).

Respected Sir,

it is most respectfully submitted that in my attempt to dispose off maximum number of cases, I have fixed short dates in oldest cases, tried to dispose off cases by way of ADR mechanism, ensured priority in hearing of oldest cases and further avoided giving unnecessary adjournments. In the assessment year 2022-23, I was required to achieve 1200 units, whereas I have achieved a total of 1637 units that is 223.08%. I have disposed of 190 cases which are more than five years old, 102 cases which are more than 10 years old and 62 cases were disposed by me during the given assessment year which were related to persons with more than 65 years of age. Further a total number of 52 civil cases were decided on merits after full contest. 35 civil cases were decided on ex-parte basis. A total number of 36 execution cases were decided. A total number of 23 cases decided during national Lok Adalat held in the given assessment year and 34 cases were decided on the basis of compromise between the parties.

As far as action plan is concerned, out of 30 oldest original suits marked in the action plan during the given assessment year, 40 oldest original suits were decided by me. Out of 10 oldest execution cases which were marked in the action plan for the given assessment year 9 were disposed off by me 1 oldest execution case could not be done because the matter was stayed by the Honorable High Court.

It is further submitted that The remarks given by the then District Judge, Kanpur Nagar in column 4 "Other remarks, if any:" is <u>as per the action plan the</u> officer was expected to decide 30 oldest original suits and 10 oldest execution cases, but the officer has decided 40/30 oldest original suits and 9/10 oldest execution case. As per the action plan the officer has decided more original suits but less number of execution cases with greater experience and effort the officer will certainly decide more cases in future and overall assessment has been given "Good." With my sincere efforts, as the presiding officer of this court I have tried with the best of my knowledge and ability to complete the target of the action plan as prescribed by the Hon'ble High Court during the given assessment year. The then learned District Judge has himself remarked that I was required to decide 30 oldest original suits but I have decided 40 oldest original suits. Out of 10 oldest execution cases which was marked for disposal in the given assessment year. I have decided 9 oldest execution cases only 1 such case could not be decided as the matter was stayed by the Honorable High Court. Most humbly it is mentioned as the Hon'ble Court is already aware about the strike of the Bar Association, Kanpur Nagar which went on for almost one and half months hampered not only the administrative work but also judicial work was highly affected which is all the more reason why one execution case remained pending and could not be decided in the given time frame.

I render my sincere apology to the Hon'ble Court that the given target of 10 oldest execution cases could not be decided in the given time frame and I could decide only 9 oldest execution cases. I assure the Hon'ble Court that in future I will make all possible efforts to dispose off more and more cases in the administration of justice. Considering the work done and total disposal in the assessment year 2022-23 by me and no shortfall in units. Most respectfully requests your good self to kindly consider my representation and expunge the remarks that-"As per the action plan the officer has decided more original suits but less number of execution cases" and further prays for upgradation of my annual entry.

For this act of grace, I shall remain highly obliged to you. It is therefore, humbly requested that respected sir may be kind enough to place my humble request before the Hon'ble court so that mercy can be done upon me.
