**Subject: Representation against Annual Confidential Remarks for the year 2022-23**

Respected Sir,

With due respect, Undersignatory have the honour to submit before the Hon'ble Court in regard to the Annual Confidential Remarks 2022-2023 as follows:-

1. That in the relevant year of 2022-2023, Undersignatory was posted as Judicial Magistrate Court No.2 & 1 as well as Principal Magistrate, Juvenile Justice board, Muzaffarnagar, from 01.04.2022 to 31.03.2023.

2. That the Annual Confidential Remarks for the year 2022-2023 has been filled by Respected District Judge on 30.05.2023 on e-services portal for judicial officers. Neither any E-mail nor any SMS received by me through e-services in regard to communication of ACR. Moreover, neither oral nor written communication was received by me on behalf of respected District Judge. In addition to that Undersignatory was facing some personal family problem due to which Undersignatory could not check online and got to know about the same in second week of June 2023. Undersignatory representing against the same before the Hon'ble Court within one month from my knowledge. Therefore, it is requested to Hon'ble Court to kindly condone the delay, if any, in representing the Annual Confidential Remarks for the year 2022-2023.

3. That the respected District Judge has been pleased to assess me '**Very Good**' on the basis of Self-Assessment submitted by me to him.

4. That the respected District Judge has certified my integrity and remarked as beyond doubt.

5. That the respected District Judge has found me as a fair and impartial officer in dealing with public and bar.

6. That the respected District Judge had found me as cool minded and does not lose temper in the Court.

7. That the respected District Judge has not found my private character is such as to lower me in the estimation of the public and adversely affects the discharge of my official duties.

8. That the respected District Judge has observed that my fixation of cause list was proper and Undersignatory have fixed sufficient number of cases to keep me engaged during full Court hours and have avoided unnecessary adjournments.

9. That Undersignatory have decided total **35 Criminal cases out of 35 in Magistrate Court** in the said year 2022-2023, out of which 1 case was of 1980, 1 case was of 1987, 2 cases were of the year 1989, 1 case was of year 1990, 2 cases were of year 1991, 9 cases were of year 1992, 5 cases were of year 1993, 6 cases were of year 1994, 2 cases were of year 1995, 1 case was of year 1996, 2 cases were of year 1997, 1 case was of 1998, 1 case was of year 1999, 1 case was of year 2000. **and 10 Criminal cases out of 35 in Juvenile Justice Board** targeted in Action Plan in 7 months. In remaining duration

undersignatory was on maternity and child care leave. As per the order dated 18.01.2023 of Respected District Judge Sir, Full week working as Principal Magistrate, Juvenile Justice Board was commenced. Before the above mentioned order, Undersignatory was working as Judiciak Magistrate, Court No.1 as well as as Principal Magistrate ,Juvenile Justice Board.

10. That the respected District Judge has also observed that Undersignatory have granted, refused or retained interim orders and injunctions for sufficient reasons.

11. That the respected District Judge has observed that my judgments on facts and on law are on the whole sound, well-reasoned and expressed in good language. The respected District Judge has also observed that my marshalling of facts are good, my appreciation of evidences and applicability of law is proper.

12. That in the said relevant year 2022-2023, Undersignatory was provided with exclusive and independent stenographer in Magistrate Court only. Undersignatory have achieved total 1815.77 Units (i.e. 151.31%) against required 1200 Units for the whole year and 563.56 units from the final disposal of cases which actually goes into the pendency reduction as per the Hon'ble Court Letter No.11/IV-h-14/2022 Dated-18.08.2022.

13. That Undersignatory have decided total 22 contested cases in Magistrate Court and 106 age determination inquiry in Juvenile Justice Board.

14. That the respected District Judge is of opinion that my control over the office and my administrative capacity and tact was good.

15. That the respected District Judge has found my relations with members of Bar and Brother Officers were good and Undersignatory was amenable to the advice of respected District Judge and other superior officers.

16. That the respected District Judge is of opinion that Undersignatory made full and effective regular inspections of my office ,court and Protection home.

17. That the respected District Judge was of opinion that Undersignatory was punctual and regular in sitting on dais in Court during Court hours.

18. That the respected District Judge has found my behaviour towards women (respect and sensitivity exhibited towards them) was good.

19. That despite of aforesaid good opinion the respected District Judge has been pleased to assess me '**Very Good**' in the said Annual Confidential Remarks.

20. That if the above Annual Confidential Remarks as '**Very Good**' is allowed to remain in existence, it may cause irreparable loss to me.

21. That in the view of above facts and circumstances, the Hon'ble Court is requested kindly to upgrade my Annual Confidential Remarks for the year 2022-2023 if deem just and proper and oblige.

You are, therefore, requested kindly to move the Hon'ble Court for favourable and kind consideration and oblige.
