8. 72 old criminal cases and 3 old civil cases decided.

9. Judgment of the Officer is based on facts and law. The appreciation of evidence is well reasoned and expressed in good language.
 10. Marshalling of facts, Appreciation of evidences and Application of law is good and sound.
 11. Target 1200 unit and achieved 2075.46 unit, percentage is 172.95%. Pendency reduction work done target is 404.84 units and achieved 1032.47 units
 12. 130 Criminal Cases and 13 Civil Cases Total 143 cases decided after actual full contest during the year.
 13. Control over the Office and Administrative capacity and tact are proper and effective.
 14. Relations with members of the Bar are balanced.
 15. Behavior in relation to brother Officers is good.
 16. Officer has made regular inspections of the Court and office in charge during the year in effective manner.
 17. He is Punctual and regular in sitting on dais during Court hours.

 21. Remarks -Performed the duties in effective manner as nodal officer Lok Adalat, officer in charge litigation, in charge grievance committee of advocates ,judgment are very sound based on fact of law and seven action plan cases have been decided in Agra.
- It is being begged to submit that inspite of no any kind of adverse remark, the overall rating has been recommended by the learned District Judge as good. With due respect it is being submitted that during my assessment year 2022 to 2023 I served Agra judgeship from 1 April, 2022 to 4 July, 2022. I have discharged the various duties in Agra including incharge statement and officer in charge night view The Taj Mahal under the direction of Hon'ble Supreme Court of India.

The learned District Judge Dr Anupam Goyal has ignored to mention the various facts regarding my duties in Agra and Disposal of action plan in District Hamirpur.

He admitted that in the small tenure of 3 months, 7 action plan cases have been decided in Agra but ignored to mention that in just a tenure of 07 months in District Hamirpur out of 35 targeted cases in action plan I have decided 31 cases of action plan under the supervision of learned District Judge and rest 04 could not be decided to due to my mid time transfer in February 2023. Various cases pertaining to year 1984-85 and further have been mentioned by the learned District Judge in his remark column but my painstaking effort have been ignored. My dedication towards the duty regarding the Taj Mahal in district Agra under the supervision of Supreme court has also not been mentioned in the remark column .

Even the percentage of my work as 172.95% and achieved target 2075.46 unit against targeted 1200 units and pendency reduction achieved units 1032.47 against required 404.84 units has also been overlooked

It is humbly submitted that this representation is not a complaint but a humble submission to the Hon'ble court to consider my painstaking effort, & dedication and get the overall assessment in ACR be upgraded from good to as the court deems appropriate.

The applicant with utmost humble request prays before the Hon'ble Court to consider my effort and output and upgrades the overall annual remark given as good by the learned District Judge Dr. Anupam Goyal. The three previous years remark is hereby written for your kind perusal.
