Subject- Request for expunging certain critical remarks recorded by District and Sessions Judge, Lakhimpur Kheri in my self assessment 01/04/2022-31/03/2023 in column number 01 (e)(iii), 01(f) and 01(g) and upgrading my overall assessment.

Respected Sir ,

The applicant most humbly requests to submit his representation on the above subject matter as under -

Applicant was posted as Civil Judge, Junior Division/ FTC (Crime Against Woman) and Additional Civil Judge, Junior Division during the self assessment year 01/04/2022 - 31/03/2023. During that period, applicant framed 559 charges, 34 issues, disposed off 1105 criminal cases, 231 civil cases, 70 criminal and 8 civil cases are decided on merit after full contested and achieved actual units 2218.70 units out of 767.52 units (without stenographer).

The remarks given by The District Judge, Lakhimpur Kheri in column 01(e) (iii), 01(f) ,01(g) are-

(1)01(e)(iii) - Disposal of old cases

Remark- 161 criminal cases and 182 civil cases old more than 05 years decided by the officer. The officer has not provided the details of disposal of action plan cases . So no affirmative opinion in the regard can be given.

My lord, as the presiding officer of above mentioned court, applicant have tried with his best knowledge and ability to complete the target of action plan. As per the action plan 2022, applicant was expected to decide 35 oldest cases. Applicant have decided 38 oldest cases out of the target of 35 oldest cases. Applicant have uploaded the list of cases decided under Action Plan on e-services portal as per the directions of Honourable High Court. Applicant never received any direction either orally or in writing to upload the details of cases decided under Action Plan in self assessment by The Respected District Judge.

(2)01(f)- With judgement on facts and on law are on the whole sound, well-reasoned and expressed in good language -

Remark- Yes, the judgements of officer on fact and law are on whole sound, well-reasoned and expressed in good language but the judgement has been written in active voice insted of passive voice. The officer should prepare the judgement in passive voice.

My Lord, the applicant had prepared the reasoning of cases in passive voice. Only examination-in-chief and cross examinations of the cases are recorded in active voice. When these examination-in-chief and cross examinations are used in reasoning, the were always used in passive voice only.

(3)01(g) whether disposal of work is adequate. (Give percentage and reasons for short disposal, if any) -

Remark- The officer has shown the achievement of units has 2654.94 but the claimed units again holidays to be included wrongly and he claimed units against computer feeding incorrect. The correct achievement is 2177.2 units against required 1200 units which is 181.43%.

The officer has not provided units achieved from final disposal during 01.09.2022 to 31.03.2023 according to G.L. NO. 11/iv-h- 14/22 Dated Allahabad August 18,2022. So no positive opinion in this regards can be given.

My Lord, applicant was not provided with stenographer. Applicant had given in hard copy his work done in which he had shown his total work done by including holidays and also by excluding holidays. On including holidays applicant have achieved 2654.94 units out of target units 1000 units (without stenographer) and on excluding holidays applicant have achieved 2218.70 units out of 767.52 units (without stenographer) which is 289.07%, By mistake the applicant could not upload the same copy with his self assessment for which he begs an apology. Applicant is annexing the copy for kind perusal.

Applicant have also uploaded the additional information in which he has shown all the cases with case number and year of case which were finally decided and were part of final disposal. Applicant have achieved 840.50 units out of target of 320.54 units. By mistake applicant did not show the units achieved from final disposal in the additional information for which he begs an apology. Applicant is annexing the copy of units achieved from the final disposal. Applicant requests to kindly consider his request.

My Lord, in work done under the heading misc. work done, in point 7 and 8, applicant have written computer feeding. Till the month of August, as per the directions of Honourable High Court, additional credit of 0.25 unit per day was given to the judicial officers for ensuring the accurate and complete

data entry and also for uploading the updated data on National Judicial Data Grid database but in August by General Letter No. II/IV-h-14/2002, dated Allahabad August 18, 2022 additional credit of 0.25 unit per day was replaced with 2 Units per week. Applicant has not claimed wrong computer feeding units. Applicant has claimed computer feeding units as per the unit system given by Honourable High Court.




