## Subject- Representation for upgradation of Overall Assessment for year 2022-23.

Sir,

Most humbly this is to submit that, I have worked as Additional District and Sessions Judge, Court No. 05, Gonda / Special Judge(Gangster Act) Gonda from 01.04.2022 to 03.07.2022. Thereafter Additional District and Sessions Judge, Court No. 06/ Speical Judge NDPS Act and have worked in the assessment period in the same capacity. The annual assessment pertaining to the work done in the assessment year, I have been rated as "GOOD". With regard to the said rating, I am submitting my representation for upgradation in appraisal pertaining to my assessment as follows:-

- 1. I was performing not only the judicial work but also responsible for administrative works of judgeship in the assessment period. During the assessment period, I had following administrative charge-
  - (i) Officer incharge of Copying.
- 2.In the assessment period, I have completed five final enquiries. This fact has been overlooked by the respected District Judge.
- 3. Alongwith my judicial work, I did my best possible effort with all due diligence to perform administrative works without any flaw and failure, which not only reflects in the performance of the judgeship as a whole but also in my own work. This administrative, financial work has not been assessed by the respected District Judge. In overall assessment, he overlooked the heavy and cumbersome work of administrative nature, which has not only delicate but also required an unfailing approach and performance, which I did with all my possible efforts.
- 4. Despite all the constraints and serious burden of administrative and financial work my total output of judicial work has been 1703.35 against target 730.96 units, which is 233.02% which is much more than the prescribed and desired target by Hon'ble High court Vide Circular No. 1418/Main-B/Admin,(A-3), Allahabad, dated 09.02.2022. This performance against judicial work culminating into nearly 233% of units has been overlooked and it has not been appreciated while appraising my overall work.
- 5. Cases under NDPS Act 1985, Drugs and Cosmetics Act 1940 and Food Safety and Standards Act 2006 were transferred on 01.09.2022 by the respected District Judge. Thus, for sessions cases under the above three acts I got only seven months time, i.e., from 01.09.2022 to 31.03.2023 instead of tweleve months time, i.e., from 01.04.2022 to 31.03.2023. Within these seven months I disposed off 1 Drugs and Cosmetics Act and 62 NDPS Act cases which includes 22 NDPS Act cases, out of 30 target cases of NDPS Act under the Action Plan.
- 6. This is also pertinent to mention that the disposal of 28 Oldest cases, 29 Execution cases has been overlooked. At the end of the assessment period only 1 execution case was pending as on 31.03.2023. This is also to mention that, total 108 cases has been disposed off as actual contested during the assessment period along with disposal of 282 bail applications and other miscellaneous criminal applications

culminating in total 390 cases against total pendency 798 cases as on 01.04.2022, which has also been overlooked. Being the presiding officer of Gangster Act court (from 01.04.2022 to 03.07.2022) and of NDPS Act/Drugs Act/Food Safety Act. I regularly performed remand work and related miscellaneous criminal work at sessions level throughout the assessment period. Therefore, overall assessment needs upgradation.

- 7. The target under action plan for Sessions trial cases was of 10 cases and in NDPS Act it was 30 cases. Under the assessment period I have disposed off 22 NDPS, 1 Drugs and Cosmetics Act and 5 sessions trials out of target cases 30 and 10 respectively which has been overlooked. This is also to mention that, total 108 cases has been disposed of as actual contested during the assessment period which has also been overlooked.
- 8. Despite all odds and constraints, I have disposed 28 action plan cases, which is 70.00% of target action plan cases, which has been taken oversight of while making the overall assessment and thus the overall assessment does not make an assessment of actual effort and positive disposal by me, which has also been overlooked.

Sir, you, are most humbly requested to place my representation with the prayer before Hon'ble Court that, Hon'ble Court may kindly please to upgrade my overall assessment, which is mentioned as "GOOD".

I shall be highly obliged.
