Subject: Submission of representation regarding remarks for Annual assessment year 2022-2023.

Respected sir,

With regards, I most respectfully beg to submit my representation on the subject noted above.

1- That during the Assessment Year 2022- 2023 the undersigned hold Court of Addl. Civil Judge (Junior Div.) Court no 22, Allahabad from 01/04/2022 to 31/07/2022 and Court of Nyayadhikari, Gram Nyayalaya, at Tehsil Meja, Allahabad from 01/08/2022 to 31/03/2023 and presently I am posted as Nyayadhikari, Gram Nyayalaya, Puranpur, Pilibhit.

2- That respected learned District Judge Allahabad has given in column 01 (e)(iv) ie. Progress and disposal of execution cases: The Presiding officer has **not disposed of any Execution Case** and in over all assessment of the merit of the officer for the year 2022-2023 as **Good**.

3- That undersigned hold court of addl. Civil Judge for only 3 months effectively and execution cases were transferred to the court in last month only, even after putting best efforts, no execution case was disposed in one month. That undersigned hold court of Nyayadhikari, Gram Nyayalaya, at Tehsil Meja, Allahabad for 8 months and only 76 civil cases were transferred and **no** execution case was transferred. Since no execution case was pending in Gram Nyayalaya, therefore no execution case could be disposed.

4- That during assessment period undersigned has achieved total 133.63 % work.

- Total 307 cases were disposed which are more than 5 years, 213 Cases which were more than 10 years and 21 Cases which were before year 2000.
- 06 Cases were decided after full contest.
- The undersigned fully disposed 35 oldest cases.
- Undersigned was appointed first Nyayadhikari in newly established Gram Nyayalaya at Tehsil Meja, Allahabad and put his every possible effort to make it fully functional and vibrant Court. Not only cordial relations were maintained with the Bar but learned lawyers were also motivated to take remain proactive and disciplined. Bar members were made fully

aware of the nature of court and its jurisdiction so that they can take proactive part in its proceedings.

- Staggering amount of Fine i.e Rs 3,50,000 (approx) was imposed and collected during short period of 01/08/2022 to 31/03/2023
- Flag hosting was celebrated with full enthusiasms and dignity with active participation by Bar and executive officers.

4- That criminal case files were received in office of Gram Nyayalaya on 10/08/2022 and civil case files on 28/09/2022 with dates already fixed up to month of November from previous Courts. Despite these constraints, the undersigned has achieved total 133.63 % work even without steno which could not provided due to shortage of staffs which effects the working of the court.

5- I have been discharging my judicial functions with utmost integrity, full dedication and to the best of my knowledge. Despite that the respected learned District Judge assessed me overall 'Good'.

6- Kindly consider my work 133.63 % work, (Perhaps, not less than any other officer getting very Good as overall assessment) disposal of cases including oldest 35 cases, quality of Judgement. It is, therefore, most humbly prayed that your goodself may kindly place this representation of mine before the then Hon'ble Administrative Judge of Allahabad Judgeship for his lordship's kind consideration. It is further prayed that the Hon'ble Court may be pleased to kindly consider this representation of mine and make my proper assessment in my ACR for the Assessment Year 2022-23 and upgrade my overall assessment proportionately.

I shall remain grateful to the Hon'ble Court for this grace throughout my life.
