overall assessment awarded in the assessment year 2022-23.


Sir,

With the utmost humility, I wish to submit that the applicant is working as Additional Chief Judicial Magistrate (ACJM) in Hamirpur and during the course of Assessment Year 2022-23, the Ld. District Judge, Hamirpur, after going through myself assessment form, has awarded me 'Average' entry as overall assessment for this year. I most respectfully wish to submit before the Hon'ble High Court that the target in respect of disposal of cases was 439.04 units against which I have achieved 1446.91 units i.e. 329.56%. I have decided 31 cases which were more than five years old. I have also decided 48 cases in the said assessment year which were more than 10 years old in the category. It is also to submit that 09 cases of person with more than 65 years of age have been decided by me during the assessment year.

It is, further, respectfully submitted before the Hon'ble Court that Workshop, Course Programme etc. organised by Judicial Academy or any other organization have properly been attended by me.

The Ld. District Judge, Hamirpur has mentioned my integrity as 'beyond doubt' and stated me fair and impartial in dealing with Public and Bar, treating me as cool minded officer who does not lose temper in the Court. My Character has also been estimated as Good. My cause list was treated proper, stating that sufficient number of cases are fixed by me to keep me engaged during Full Court Hours. I have also avoided unnecessary adjournments. 04 cases have been decided by me which were more than 25 years old. I have also decided 15 cases related to Execution.

It is also respectfully submitted that 09 cases related to MP's & MLA's have also been decided by me during the period when Jurisdiction lies with



me. More than 600 units have also been achieved by me through the Judgment as ascertained by the Hon'ble Court.

The Ld. District Judge, Hamirpur has stated that my marshalling of facts and the appreciation of evidence are satisfactory, whereas the same learned District Judge has treated my marshalling of facts and appreciation of evidence as good in the previous Assessment year 2021-22. The column relating to appreciation of Law has been assessed poor in current assessment, whereas in the previous assessment year, the same Ld. District Judge estimated as sound, the Ld. District Judge, Hamirpur has mentioned in the previous assessment year, that the judgement are based on facts and law. The appreciation of evidence is well reasoned and expressed in good language, whereas in the present assessment year, the same Ld. District Judge has estimated that the appreciation of evidence is not up to the mark. No specific case has been mentioned in the column that in which particular case/judgment, the appreciation of evidence is not upto the mark.

The District Judge, Hamirpur has mentioned in column no.4 Avoid shouldering responsibility, his remark appears to be adverse. In this regard I have to submit that the District Judge, Hamirpur has not mentioned any incident in which I have avoided shouldering the responsibility. If this remark remains as it is, it may affect my future carrier.


