- 1. Annual Confidential Report** recorded for the year 2022-2023 by learned District Judge Meerut w.r.t. undersigned was uploaded on 15/07/2023.
- Kindly refer column no. 01 (a) following remarks has been recorded by learned District Judge quote, "Nothing on record to suspect her integrity." and column no. 4 i.e. other remarks if any, of ibid ACR quote, "The officer has decided 10 oldest PC Act cases against target of 10, 06 oldest session trials cases against target of 20 as Special Judge Anti-corruption. The officer has decided 23 oldest Session Trial cases target of 25, 10 oldest Criminal Appeal cases against target of 10, 15 oldest Gangster Act cases against target of 15, 10 oldest Civil Appeal cases against target of 10, 10 oldest Execution against target of 10 as Special Judge Gangster Act. The officer has also decided 01 oldest Execution Civil (contested) & 28 Execution Civil (non-contested).
- Applicant's Jurisdiction of court got changed four (04) times during the assessment year 2022-2023** as a result applicant served as Spl Judge Anti-corruption Act 1988 for 05 months (i.e. 01.04.2022 to 04.07.2022 & 30.01.2023 to 31.03.2023), Additional Distt. & Session Judge for 02 months (i.e. 05.07.2022 to 26.08.2022) & Additional District & Session Judge having jurisdiction of the UP Gangsters and Anti-Social Activities (Prevention) Act 1986 for 05 months (i.e. 27.08.2022 to 30.01.2023).

**Thus applicant's target proposed for old cases & cases of specified categories under Action Plan 2022-2023 kept changing accordingly with**

the change in jurisdiction of court as per direction vide Do no. 148 CF (B) / 2022 dated 26.03.2022 of Hon'ble High Court.
