

Representation Against Remarks of District Judge

It is most humbly submitted that in Annual Confidential Remarks of 2022-2023 given by respected District Judge Mirzapur, my overall conduct, Integrity, punctuality and relation with bar and brother officers has been stated to be proper and good. The District Judge has also emphasized this rating by adding that nothing adverse has come to his knowledge by any source whatsoever, whether from the bar, other officers or court employees. Therefore I do not have to submit any prayer regarding the above rating. The only thing which I would pray and highlight is that prior to my posting at Mirzapur I had been posted at Auraiya Judgeship in the same assessment year. I had been entrusted important administrative work by District Judge Auraiya I was in charge of Litigation as OSD Litigation to pursue all matters in Honourable High Court related to the judgeship. I had also been attached to Infrastructure Committee to help in its working. I completed all the assignments to the satisfaction of my District Judge. Although I was senior but I had not been entrusted with any Administrative work by respected District Judge Mirzapur since my joining at Mirzapur that is 6.7.2022 till I left charge on 28.4.2023. I would humbly submit that I had disposed one five years old case at Auraiya as mentioned as mentioned in column 2A of my self-assessment form which was not mentioned by District Judge Mirzapur in Annual Confidential Remarks column number 1(e)(iii) and was shown to be nil. So Also I had decided three Arbitration Execution cases at Mirzapur which was shown to be nil in column 1(e) (iv) of Annual Confidential Remark column awarded by District Judge Mirzapur.

It is my most humble prayer to the Honourable Court that I want to make a representation and pray for adverse remarks given to me by District Judge Mirzapur in column number 2, 3 and 4 of Annual Confidential Remark submitted by District Judge Mirzapur. It is most humbly submitted that I have been awarded poor rating by District Judge Mirzapur for only a period of 13 days of my presence at Mirzapur. It is my humble prayer that I have been awarded poor rating not for my work but as a punishment for being on leave. No administrative work or department had been entrusted to me since my joining so no question arises to satisfy my District Judge in that area. Hence I pray the Honourable Court to expunge the remarks and rating done by the District Judge and save me from the great injustice done to me and my career just as I was on leave due to my personal and family problems.

It is my most humble submission that I am fully fit and physically well as any judicial officer should be. I suffered with cervical spondylitis and vertigo during that period. My wife is a Doctor and was posted at G.S.V.M. Medical College Kanpur. My only son is of 8 years old and was studying at Kanpur. My parents are not alive. There is no one to take care of my family at Kanpur. As I suffered from spondylitis and vertigo nobody was there to take care of me at Mirzapur. So also my family was alone at Kanpur. As Annual transfer was



made in the month of July and I was transferred in the month of July till then academic session had started and my only son was admitted in a school at Kanpur. So It was not possible to get my son admitted in a school at Mirzapur and my wife is a Doctor at G.S.V.M Medical College at Kanpur so she also could not come to my place of posting at Mirzapur. My family was alone at Kanpur and open to all kinds of risk.

I had to take Medical leave for some time due to spondylitis and had to take rest as per advice of orthopaedician. I suffered severe pain and Vertigo at that time. Nobody was there to take care of me at Mirzapur hence I had to come to Kanpur without any choice. I got some relief from spondylitis but still needed to be at Kanpur to support my Family living alone and uncared I tried to take Half Pay Leave or Earned Leave for which I was not permitted and my District Judge refused to forward the leaves . Hence I had to extend my medical leaves that is why I had to take 183 days Medical Leave.

It is my humble submission that I represented to Honourable Court on the account of my family problem on above said grounds and my prayer was accepted by the Honourable High Court and my representation to be transferred from Mirzapur was allowed and I finally got transferred from Mirzapur on April 2023 for which I will be highly indebted to Honourable High Court throughout my life. I remained posted at Mirzapur for about 9 Months (July-March) for which I have been awarded with adverse remarks. The total number of working days came to be 13 days for which adverse remark has been awarded.

In the last I will pray to the Honourable Court that I am healthy and have worked throughout my career of about 20 years performing to the satisfaction of all my District Judges both on Administrative and Judicial Side. This was a short period of about 9 months during which I was ill and my family was in Problem. Grave Injustice would be cast upon me and my career (I am expecting a promotion in near future) if these remarks prevail. I pray to the Honourable Court to Expunge the poor rating and improper health rating made in the Annual Confidential Report by Respected Judge Mirzapur and bless me and my Family.
