The District Judge certifying the integrity of the officer and assessed overall his performance as "Good" but general repute with the Bar and in public is not good. In this regard I want to draw the kind attention of the hon'ble court/committee that the Hon'ble Administrative Judge has not certified my integrity on the sole basis of a single complaint that complaint letter/affidevit was filed by **Advocate Mujeeb Ur Rahman on behalf of his client Farmeen** regarding the rejection of bail application of her husband who was involved in case crime number: 355 /2021 under section 2 / 3 Uttar Pradesh gangster and prevention of anti social activities act ,1986. The said accused had also several criminal antecedents. The offence was non-bailable and accused had criminal history. Due to this reason I have rejected his bail application on merit. No question arises of any bribe /extraneous consideration . Except this complaint there was no other complaint regarding my integrity. Hapur bar association, Hapur had also filed complaint/letter regarding the rejection of this bail application .The office bearers of the Hapur Bar Association, Hapur wanted to pressurize me to grant this bail to the accused.

With due respect I want to submit this thing that I have completed my judicial service of 19 years. No Learned District & Sessions Judge has raised any doubt about my integrity. My judicial career is totally depends upon the kind hand of the Hon'ble Court /Committee. All District & Sessions Judge have certified my integrity.

If the remark recorded by Hon'ble Administrative Judge Sessions division Hapur remain as it is, it will adversely affect my future judicial career. Hence it is necessary to expunge the remarks recorded by the Hon'ble Administrative Judge Sessions division Hapur and upgrade my over all assessment.

My wife has been suffering from breast cancer since May, 2019. She is still under treatment and supervision of doctors of All India Institute of Medical Sciences, New Delhi, National Cancer Institute. Jhajjar. Due to this reason I could not see/peruse the e-sevices portal/on date 31 August 2023, when I saw my remarks, I came to know the remarks recommended by the Hon'ble Administrative Judge are adverse.

I, therefore, humbly request you to kindly place my representation before Hon'ble Court/Committee for sympathetic consideration and to expunge the remarks recorded by Hon'ble Administrative Judge Sessions division Hapur for the year under Assessment Year 2021-2022 and upgrade my overall assessment. I shall be highly thankful to the Hon'ble Court/Committee for its kindness.
