I have decided 08 old cases which are of the category of more than 10 years old cases and 11 old cases which are of the category of more than 05 years old cases during the assessment year 2022-23. During assessment year, I have decided 03 execution cases with full satisfaction. During the assessment year 2022-2023, I have decided 927 Bail Applications and also recorded statements of 341 witnesses. During the assessment year 2022-2023, total 34,255 cases have been disposed in four(4) Lok Adalats under my supervision in Auraiya Judgeship. During the assessment year 2022-2023, I have achieved 1449.60 Units against the required units 770.32 i.e. 188.18%.

In the connection of complaint dated 19.01.2023 made by Smt. Rajani Singh, The then Principle Judge, Family Court, Auraiya, it is to submitted that I have accordingly made payment of the bills of the vehicle provided to The Principle Judge, Family Court, Auraiya for the month of September & October, 2022.

In the connection regarding complaint made by Advocate Sri Manjul Mishra against me it is to submitted that the complaint made by Advocate Sri Manjul Mishra has also been withdrawn by him.



During the assessment year, on 01.04.2022 I have peacefully settled the issue of jurisdiction of outline court at Vidhuna in Auraiya judgeship, for which advocates were on strike since 2007 in Auraiya judgeship. During posting in Auraiya judgeship, land for the District Court building and residences for Judicial Officers in Auraiya judgeship has also been acquired by my efforts.

Therefore, I kindly request that my representation may be presented before The Hon'ble Court with utmost humility. I humbly request that considering my promising career, the overall assessment for the year 2022-2023 be upgraded from 'good'. Additionally, I request that mention of complaint made by Sri Manjul Mishra and complaint made by Smt. Rajnish Singh, the then Principal Judge, Family Court, Auraiya may also be removed from the overall assessment in the light of the points, I have submitted above.
