Subject : Representation against remark of respected  
District Judge over self assessment 1-04-2022  
to 31-03-2023.

Respected Sir/Madam,

This representation is hereby being  
humblly submitted to state that for the last  
assessment year I had worked as Civil Judge (Jr. Div.)  
Ghazipur from 1-04-2022 to 4-07-2022 and  
Civil Judge (Jr. Div.) Fatehpur from 6-07-2022 to  
31-03-2023.

Hon'ble Sir/Madam, most respectfully I would  
like to submit that during the abovementioned  
period of self-assessment I have achieved 934  
units of work against the actual required target  
of 492 units.

As per the remarks of respected District

Judge according to General letter no. 11/N- h-14/2022 dated Aug. 18 2022 I have achieved total 125.50 units of work against target of 118.08 units.

→ As Civil Judge (Jr. Sir) I have decided 7 civil cases after full content, 17 cases on the basis of compromise and 40 cases in Lok Adalat.

→ I have disposed 27 execution cases.

→ I have disposed 233 cases which were more than 5 years old.

→ 108 cases more than 10 years old have been disposed by me out of which some were the oldest pending cases in the entire Fatehpur Judgeship.

Hon'ble Sir/Madam,

With utmost respect I would like to most humbly state that on the basis of my work respected District Judge has assessed my work as "Good" which to my belief is not just and proper assessment of my work.

Hon'ble Sir/Madam,

I would most humbly like to bring to your kind attention to the fact that current respected District Judge has taken the charge of District Judge Fatehpur in the month of September 2022. Ever since he has taken the charge his

behaviour has not been appropriate towards me in one way or the other for the reasons best known to him and unknown to me.

Hon'ble Sir/Madam, I would most humbly like to bring to your knowledge the entire series of incidents that unfolded one after another from the date of his joining in the month of September 2022 till now that will clearly reflect upon his inappropriate behaviour and ill-conduct towards me which have deeply affected me both personally and professionally. The series of events are as follows:-

Firstly,

Ever since respected District Judge has joined as District Judge Fatehpur, he used to call me at highly inappropriate timings, such as 11 pm. in the night or 6 am. in the morning for no official purpose whatsoever. He used to keep on asking about unnecessary personal details i.e., about my family members, my fiance (at that time), my education, my hobbies, about my upcoming marriage etc. and used to keep on talking for hours.

Secondly,

During court hours he used to call me in his chamber very often without any specific reason and used to talk about personal stuff for long durations. Once when I asked him about the reason of calling me to his chamber, he said and I quote "मैं तो कारियर करता हूँ कि किसी ना किसी बहाने से तुम्हारा सु-दर चेहरा देखने को मिल जाये"।

After few days of tolerance to this absurdity I lost my patience and went to his chamber and requested him not to call me unnecessarily on phone or to his chamber unless there was anything official to be communicated to which I shall be ready for compliance. On this he became very jealous but stopped calling me unnecessarily from then.

Hon'ble Sir/Madam, I would request you that if the authenticity of above statements is to be verified kindly fetch my COR.

Thirdly,

Hon'ble Sir/Madam, I could have complained about these things to the internal complaints committee at that time but since my marriage was due in the month of December, therefore

I wanted to avoid any such complaint that-  
could seriously cause hindrance in my marriage  
and further affect my reputation adversely at  
such crucial times. (5)

Fourthly,

Hon'ble Sir/Madam, On various occasions  
respected District Judge has been passing  
inappropriate comments about my looks,  
appearance, physique etc. in front of fellow  
Judicial officer which has often made me  
extremely uncomfortable at times, but I kept on  
ignoring such conduct on his part since it  
could create problems in my personal  
newly married life.

Fifthly,

Hon'ble Sir/Madam, The height of his  
indecent ~~behaviour~~ and inappropriate behaviour  
reached when on 11th May 2023 he started  
howling at me and my husband in front of  
all judicial officers of Judgeship. I would  
briefly like to narrate the entire incident  
that took place in the meeting hall of  
Fatehpur Judgeship in front of all fellow offices.  
on 11th May 2023.

Hon'ble Sir/Madam,

A meeting was called by respected District Judge in the meeting hall of Pachpur Judgeship on 11th May 2023. I along with my husband who is also a judicial officer were sitting in the meeting hall with all fellow officers of the Judgeship. After a wait of around 15 minutes respected District Judge came out of his chamber and started the meeting. After a while he started shouting at me regarding a letter sent by me related with infrastructure in J.J.B. which has been annexed with this representation for your kind perusal.

Hon'ble Sir/Madam,

Respected District Judge started shouting at me in front of all fellow officers and said that "आप कोई काम खुद नहीं करना पाहती हैं। आप यहाँ से जाती हैं और पीटे से आपका letter यहाँ आता है।"

Hon'ble Sir/Madam, then he started shouting at my husband in a very high

pitch, who was just transferred to Fatehpur  
judgeship and had nothing to do with this  
official matter. He said to him - " तुम अपने  
आप को पढ़ने लिखने में बहुत तेज़ समझते  
हो कि हर बात ये बड़ी चालाकी से letter  
ज्ञाप दोगो ।"

Hon'ble sir/Madam , at this point I would  
like to bring to your knowledge the fact that  
when I joined as Principal Magistrate J.J.B.  
in the month of May 2023 , I orally communicated  
to respected District Judge about the conditions  
of Infrastructure there. In response to this  
he himself asked me to write down a  
letter to him highlighting about the problems  
there, so that necessary measure could be  
taken on his part . But when in compliance  
of ~~to~~ ~~to~~ his order I did the same , he  
got offended and howled at me and my  
husband in the meeting hall in front of  
all the fellow officers.

Hon'ble sir/Madam , here again I  
would like to mention the fact that when  
the abovementioned letter was sent by me,

No reciving of that letter was given to me and this incident took place. Thereafter I had emailed that letter on the official website of Fatehpur Judgeship. Following this incident I suspected District Judge kept on refusing to give me reciving on further official communication made by me. Therefore, I had to use online forum for further correspondence the details of which are available on the official mail i.d. of Fatehpur Judgeship.

Hon'ble Sir/Madam. This behaviour on the part of suspected District Judge has deeply affected my ~~phys~~ psychological and physical health. He has created a state of constant trauma, humiliation and disgust for me at the workplace. Due to his indecent remarks and inappropriate conduct towards me I feel a constant state of mental agony, pain, unrest and panic at the workplace.

Finally, to conclude I would like to most  
 humbly state that respected District Judge has  
 through his conduct both verbally and non-  
 verbally expressed bad behaviour towards  
 a female judicial officer. Therefore I  
 would request you to kindly treat this  
 representation of mine as an official complaint  
 against him for consistently showing  
 disrespectful behaviour towards me. Hon'ble  
 Sir/ Madam, the ACR given by him to me  
 is to my deepest belief completely clouded  
 by his prejudice against me and has nothing  
 to do with my dedication, hardwork and  
 performance at my work.

At last I would most humbly  
 request you to kindly accept my representation  
 for the purpose of awarding ACR to me.  
 I will be highly obliged.
