Subject:- Submission of Representation against remarked by the learned District Judge Sambhal for the assesment year 2023-2024.

Respected Sir,

I must respectfully beg to submit my representation on the subject noted above as under.

1. It is humble submitted that the remark given by the learned District Judge upon my self assesment form for the assesment year 2023-24 were comunicated to me on 29-05-2024 throuh the e-service portal for the judicial officers where in the Learned District Judge while assessing my overall performance as "good" has remarked in column no.-01(a) regarding interegrity of the officer that "complaints against integrity is received but no of them was substained by any solid evidence". The Learned District Judge has also remarked the judgement/order delivered by me as "B" Good in column no.-01(f)(iv) of the remarks. These remarks may adversely affect my future carrer prospects as well as my cause damage to my clean past carrer. So I am Submiting my representation on the following grounds.
2. It is humbly submitted that the remark in column no.-01(a) regarding integrity of the officer is based upon some complaints against integrity but the Learned District Judge has not given any details of any such matters which has caused inpediment in experssing her satisfaction regarding my integrity. Rather the Learned District Judge recorded that there was no solid evidence to support her remarks and column no. 01(b) remark "Yes" he is fair and impartial in dealing with public and Bar. Now days it is very common that any party files complaints against the judicial officers to delaying the proceeding and avoid the disposal of cases.
3. The Learned District Judge has also not properly assesed the Judgement delivered by me as "B-Good" in coloumn no. 01(f) of the Remarks. I have delivered well reasoned judgment in all streams of the cases with the appreciation of law and facts. The District Judge

has also her self recored in Column No. 01(f)(i), 01(f)ii, 01(f)iii marshaling of facts appreciation of evidence and application of law as proper. The above Remark in Column no 01(f)iv does not justify the quality of judgemet delivered by me. So I need to upgrade.

4. It is humbly submitted that achieved total 2528.91/unit as against the precribed standard of 1200 unit total percentage of work done 339.87%. Apart for it I decided tatal 151 Cases which were more tha 5 Years old and 62 Cases which were more than 10 Years old. 30 Cases are decided by me which were related to litigants who were older thn 65 years of age. Keeping in views the quantum of judicial work done by me. I deserved on upgraded over all remarks but it appears that the Learned District Judge due to her Remark in the Column no. 01(a) and 01(f)iv constrained herself to award my overall assesment as "Good".

5. It is there fore most humbly prayed that the remarks awarded to me in column no. 01(a) of remarks regarding the District judge in my ACR for the assesment year 2023-24. May kindly be expunged and upgraded to match my integrity and honesty. The Remark in Column no. 01(f)iv regarding judgment and my overall assesment may kindly be upgraded to Outstanding.

6. It is most humbly prayed that I have so for served for less than 05 years in District judiciary and have got appreciated service record so for and have never earned any displeasure from any of my previous District Judge or for the Hon'ble Court and have always tried to discharge my duties with it must devotion and dedication there to. It is therefor must humbly prayed that your good self may kindly place this representation of mine before the Hon'ble Adminsitrative Judge of Sambhal Judgeship for his lord Ship's kind consideration it is furthers prayed that the Hon'ble Court may be pleased to kindly consider this representation of mine and make my proper assessment by expunging the aforesaid only adverse remarks as recorded by then Learned District Judge in my ACR for the Assesesment Year 2023-24. I shall remain grateful to the Hon'ble Court for this grace throughout my Life.
