With reference to the above captioned subject, it is most humbly submitted that I am currently posted at Hamirpur judgeship in the court of Civil Judge(S.D.)/FTC.

That during the assessment period of 01.04.2023 to 31.03.2024, I have been posted as a Judicial Magistrate, Orai from 01.04.2023 to 20.09.2023 and thereafter as Nyayadhikari, Gram Nyayalaya, Madhogarh, Orai from 21.09.2023 to 20.11.2023. That I was transferred to Hamirpur Judgeship by the orders of the Hon'ble court in the court of Civil judge (Senior Division)/FTC, Hamirpur and has held the court from 21.11.2023 to 31.03.2024.

It is most humbly submitted that during my tenure as a Judicial Magistrate, Orai, '**No Execution**' case was pending in my court. That upon my transfer as Nyayadhikari, Gram Nyayalaya, Madhogarh, Orai, the total number of execution cases which were pending were 6 and out of which I have '**Disposed off 1 Execution case**' marked under the **Action Plan 2023-24 within short period of time.**

Further, it is most humbly submitted that I was transferred to Hamirpur Judgeship by the orders of the Hon'ble court in the court of Civil judge (Senior Division)/FTC, Hamirpur on 21.11.2023.

That at the time of joining 'No execution case' was pending in my court. That the respected District Judge, Hamirpur vide order dated 20.02.2024 transferred total 8 execution cases in my court and which were received on 23.02.2024. It is most humbly submitted that after the said files were received upon transfer, the notices were issued to parties on date fixed as per the rules laid down under General Rules(Civil). That I have made all serious and sincere efforts for completion of my execution case by 31.03.2024.

It is most humbly submitted that, the respected District Judge, Hamirpur has recorded the entries in Annual Confidential Report (ACR) for the financial year 2024-25. That while recording the remarks at point 01(e)(iv), against the entry of 'Progress and disposal of execution cases' the remark of 'NIL' has been recorded.

It is humbly submitted that I have disposed of the execution case in the assessment year and for which the same has been shown in the pendency statement attached while filling out the self assessment form.

It is humbly requested and prayed before the Hon'ble court that the court may be pleased considering my bright carrier ahead to expunge the remark of entry recorded by Respected District Judge, Hamirpur against point 01(e)(iv). I shall be highly obliged to Hon'ble Court for its kind consideration.
