Subject: Representation seeking proper overall reassessment of the ACR entry for the assessment year 2023-2024.

Respected Sir,

In reference to the above-mentioned subject matter, with due respect, it is most respectfully submitted that :

1. I have been posted in the District Court Rampur since 1 May 2023 as the Additional Civil Judge (Junior Division). The ACR of the undersigned for the assessment year 2023-2024 has been recorded by the Learned District Judge Shri Satya Prakash Tripathi.
2. The Learned District Judge, Rampur has certified the integrity of the undersigned as beyond doubt and has observed that the undersigned is impartial and fair in dealing with the public and bar.
3. The Learned District Judge, Rampur has appreciated the undersigned for being cool-minded and not losing her temper.
4. The Learned District Judge, Rampur has certified that the undersigned fixes a sufficient number of cases to keep herself engaged and also avoids unnecessary adjournments in cases listed before her.
5. With respect to the judgments delivered by the undersigned the Learned District Judge, Rampur has observed that the Judgments are on the whole "sound, well reasoned, are expressed in good language", and are based on "proper marshaling of facts and appreciation of evidence". Further, it is also observed by the Learned District Judge that relevant case laws had been applied in the judgments. Overall the judgment writing capability has been categorized as **"Very good"**
6. The Learned District Judge, Rampur has observed that the relation of the undersigned with bar and sister/brother officers has been good

throughout and no adverse incidents have been reported. It is also recorded that the inspections made by the undersigned are full and effective and that the undersigned is punctual and regular in sitting on dias during court hours.

7. It is further observed that the undersigned is "respectful and sensitive towards women, is amenable to the advise of the District Judge, and is sincere and hardworking."
8. With respect to the disposal of cases, it has been recorded by the Learned District Judge Rampur, that "out of 1200 units required for the relevant year a total of 1605.50 Units have been achieved". Out of which the units achieved throughout complete disposal is 730.55 units.
9. In addition to it, the following is the list of cases disposed of by the undersigned in the relevant assessment year:

Old and oldest cases (Civil) - 19

- a. Civil Contested Judgments- 5
- b. Civil ex parte Judgments - 3
- c. Original civil suits disposed of through compromise and withdrawal - 17
- d. Old and oldest cases (Criminal) - 26
- e. Criminal Contested - 10
- f. Oldest criminal cases disposed on probation - 2
- g. Cases disposed in Lok Adalat - 292
- h. Units achieved through complete disposal-730.55 units

A list of all the cases was annexed along with the self-assessment form and is also being annexed herewith this application.

10. Despite the above-mentioned observations the Learned District Judge in column no 2 has assessed the overall performance as "good". It is respectfully submitted that the undersigned has never derelicted from her duty. Despite being on leave for 2 months in the relevant assessment year due to the Retinal Displacement Surgery in the Right Eye the undersigned managed to achieve more than the prescribed quota. It is respectfully submitted that for the year 2023-2024, the work done by the undersigned was **1605.50 units** which is substantially more than the prescribed quota. The work done includes the disposal of a substantial number of contested judgments and action plan files.

11. It is respectfully submitted that the undersigned was not issued any D.O. by the learned District Judge, for her behavior, conduct, or Judicial work.
12. In view of the above facts and circumstances, the assessment of the overall performance of the undersigned as "good" in column 2 is unreasonable and without any ground and therefore is liable to be reassessed.

The undersigned requests therefore to your good self to place this representation before the Hon'ble Administrative Judge of District Court, Rampur for His Lordship's kind consideration, I most respectfully pray to His Lordship to kindly reassess the overall performance of the undersigned in column no. 2 in the ACR entry for the assessment year 2023-2024.
