- 1. It is humbly submitted that the remark recorded by the District Judge in the Annual Confidential Report for the year of 2023-24 were communicated to me through online portal on 31.05.2024.
- 2. The applicant brings to your kind notice that during the assessment year of 2023-24, applicant's court were frequently changed. I presided over the court of Chief Judicial Magistrate, Budaun (01.04.2022 to 28.04.2023), Civil Judge (Senior Division) Fast Track Court, Kannauj (29.04.2023 to 01.09.2023), Additional Chief Judicial Magistrate-2, Muzaffarnagar (02.09.2023 to 20.11.2023) and Civil Judge (Senior Division) Muzaffarnagar (21.11.2023 to 31.03.2024).
- 3. The net units which were required to be achieved by applicant in the year 2023-24 are 721.6 units. However, applicant achieved 2319.68 units by his work. The percentage of work is 193.30% units, which are far more than required units.
- 4. The applicant leaves no stone unturned to decide the cases categorised as 'Action Plan'. Out of 04, 03 complaint cases have been decided on merit in a short span in ACJM.
- 5. Apart from it, applicant contributed in administrative work which was entrusted to him. I was officer incharge Amin, Member Infrastructure committee in Muzaffarnagar and officer in charge record room in Kannauj Judgeship. The District Judge also recorded as officer has effective control over the office and he possesses good administrative capacity and tact.
- 6. It is worthy to mention here that while giving entry the Respected District Judge has taken into consideration applicant's integrity which was certified by him as 'Beyond Doubt'. No complaint was ever received against the applicant.
- 7. The applicant's punctuality in court and office is also certified by the Respected District Judge.It is also certified that officer is respectful and sensitive towards women.

- 8. It is important to mention here that I was never advised or suggested to improve in any facet of my work and I was always found alert in discharge of my duties. I have always been amenable to the advice of the District Judge. The Respected District Judge never pointed out any laxity or infirmity or any fault in discharge of judicial work.
- 9. It is further submitted that the "GOOD" entry in overall assessment of the applicant is not commensurate with my performance. Keeping in view my overall performance, if the overall remark is upgraded then it will be a motivating factor for me and I shall be able to perform whole heartedly with more zeal and enthusiasm in future.
- 10. Therefore, it is most humbly prayed that "GOOD" entry does not properly justifies the efforts which I put in my divine judicial work during the said assessment year. Hence it is humbly requested that above mentioned facts may kindly be considered and "GOOD" entry in column number 2 regarding overall assessment may kindly be upgraded to any other higher suitable entry which the Hon'ble Court deems fit.
- 11. It is requested with utmost humility that my representation may kindly be placed before the Hon'ble Court for kind and sympathetic consideration.
