Subject- **Representation against Annual Confidential Remark given by Principal Judge Family Court, Agra in Annual Self Assessment 2023-2024 and upgradation of overall Assessment. (Case ID No. A00023442024).**

Respected Sir,

With utmost regard, I submit the following for your kind consideration and appropriate action-

- 1- In Annual Confidential Remark 2023-2024 Learned Principal Judge, Agra while recording the remark in column No.3 regarding State of Health has mentioned as "**Appears Healthy and Fit to perform Judicial Duties.**"
- 2- The word "Appears" used in column No. 3 is improper, unreasonable and indignified in itself as I have never availed any medical leave during my whole service tenure. This questionable word "Appears" is used without mentioning any reason or ground. There is no oral or written instance of any sort.
- 3- I have performed my Judicial duties, responsibilities and Administrative work in diligent and effective manner. During the Assessment year 2023-2024, my Achieved Units were more than 251 percent than the Required Units. Also the Actual Units Achieved against the Units Required from final disposal of cases which actually goes into pendency reduction were more than 253 percent. This includes 100 % disposal of oldest cases more than 10 years old in Criminal as well as Civil side.
- 4- As per Targeted Action Plan for Civil and Criminal Cases for the Assessment Year 2023-2024, I have disposed 25

Civil Cases out of total Targeted 25 Civil Cases and 73 Criminal Cases out of total Targeted 75 Criminal cases, which reflects 100 % achievement of Action Plan in Civil cases and 97.3 % achievement of Action Plan in Criminal cases.

5- Apart from this, it is also mentionable that I have disposed 88 Criminal Execution Cases and 5 Civil Execution Cases but Ld. Principal Judge have mentioned in column No. 01 (e) (iv)- "Total 5 Execution Cases decided;" and not mentioned disposal of any Criminal Execution Case which is an apparent error. This shows that while assessing my performance for overall assessment Ld. Principal Judge overlooked the disposal of Criminal Execution Cases as well as the disposal of Action Plan Cases.

6- In the light of above elaborated facts, Hon'ble Court is being **prayed for expunge the word "Appears" mentioned in column No. 3**. Hon'ble Court is further being requested to **upgrade my overall assessment**. I shall be highly obliged.

It is being requested to place my representation before Hon'ble Court for kind and sympathetic consideration.
