Subject:Representation against the overall assessment during the Assessment Year 2023-24 as recorded by Shri Vinai Kumar Dwivedi, Learned District Judge, Muzaffarnagar.

Sir,

I most respectfully beg to submit my representation on the subject noted above as under:

- 1. That I belong to the 2018 batch of Civil Judges (Junior Division) and joined my judicial service as Judicial Magistrate-II, Mahoba on 18.11.2019 and thereafter underwent my foundation level training conducted by the Institute of Judicial Training & Research, Uttar Pradesh, Lucknow.
- 2. That during the Assessment Year 2023-24, I served as Additional Civil Judge (Junior Division) in Mahoba from 01.04.2023 to 28.04.2023, Judicial Magistrate in Muzaffarnagar from 01.05.2023 to 20.11.2023, as Additional Civil Judge (Junior Division) in Muzaffarnagar from 20.11.2023 to 01.01.2024, and from 01.01.2024 to 31.03.2024 as Civil Judge (Junior Division) in Jansath, Muzaffarnagar.
- **3.** That the learned District Judge, Muzaffarnagar has recorded following appreciative entries in my ACR for the Assessment Year 2023-24:

"integrity-beyond doubt, fair & impartial in dealing with the public & bar, cool minded, there was nothing adverse against my private character, fixing of cause list-proper, sufficient number of

cases fixed to keep engaged during full court hours, unnecessary adjournments avoided, judgments on facts and law-sound and well reasoned and expressed in good language, marshalling of factsgood, appreciation of evidence-proper, application of lawproper, quality of judgement-good, total work done-2077.80 Units against the prescribed 1200 Units i.e. 173.15% which is adequate and above the norms, used to grant or refuse interim orders & injunctions for sufficient reasons, control over the office and administrative capacity & tact-good, relation with members of Bar- Balanced and cordial, behaviour in relation to brother officers-good, inspections of court & office-full & effective, punctual and regular in sitting on dias during court hours, amenable to the advice of the District Judge & other superior officers, behaviour towards women, respect and sensitivity exhibited towards them- officer is respectful and sensitive towards the women, state of health-normal, overall assessment of the officer-"Good". As per the action plan officer has decided 25 Criminal cases, 11 Original Suits & 04 Execution Cases. As per Hon'ble Court Letter No. 11/ IV-h-14/2022 Dated- 18.08.2022 Officer has achieved 826.93 Units from the final disposal of cases which actually goes into pendency reduction.

- 4. That during the assessment year 2023-24 I had achieved a total of 2077.80 units as against the prescribed 1200 units i.e. 173.15%. Further I had achieved a total of 826.93 units against the prescribed 323.95 units which is 255.26%. The Action Plan 2023-24 given by the Hon'ble Allahabad High court has been achieved in its entirety i.e. 25 Criminal Cases & 11 Civil Cases & 5 Execution Cases . As far as civil and execution cases are concerned till 20.11.2023 the applicant was holding criminal court therefore no such cases were pending. The applicant held civil court in April,2023 thereafter from 20 November 2023 till 31 March 2024.
- 5. That during the assessment year 2023-24, I disposed of 71 criminal cases that were more than 5 years old and 88 criminal cases that were more than 10 years old. Regarding the oldest criminal pendency, I disposed of 1 case of 1985, 1 case of 1987, 1 case of 1990, 1 case of 1992, 5 cases of 1993, 7 cases of 1994, 2 cases of 1995, 2 cases of 1996, 4 cases of 1997, 6 cases of 1998, 3 cases of 1999, and 6 cases of 2000.
- 6. That during the assessment year 2023-24, I presided over civil court for a period of about 5 months and disposed of 35 civil cases that were more than 5 years old, as well as 23 civil cases that were

more than 10 years old. Regarding the oldest civil pendency, I disposed of 1 case of 1999, 1 case of 2000, 2 cases of 2002, and 3 cases of 2003. During this assessment year, I also disposed of 6 execution cases. Additionally, a total of 1770 cases were disposed of in the National Lok Adalats held during the assessment year.

- I have so far served for less than 5 years in the subordinate judiciary. During this period, I underwent one year of foundation level training. I have an appreciated service record and have never received any displeasure from any of my Learned District Judges or from the Hon'ble Court. I have always performed more work than required, striving with full devotion to my duties as a judicial officer. I conscientiously assure the Hon'ble Court that I will continue to perform a considerably high volume of work in the future. However, the overall assessment of my merit in my Annual Confidential Report (ACR) for the year 2023-24 at serial No. 2 is discouraging to me, despite my extensive efforts. I have no recourse other than to represent my grievance before the Hon'ble Court.
- 8. It is, therefore, most humbly prayed that your goodself may kindly place this representation of mine before the then Hon'ble Administrative Judge of the District Court, Muzaffarnagar for His Lordship's kind consideration. It is further prayed that the Hon'ble Court may be pleased to kindly consider this representation of mine and make my proper assessment by upgrading my overall assessment as recorded by the learned District Judge, Muzaffarnagar in my ACR for the Assessment Year 2023-24. I shall remain grateful to the Hon'ble Court for this grace throughout my life.
