Subject: Representation against the only adverse remark regarding disposal of only 01 execution case not on merit during the Assessment Year 2023-24 as recorded by Shri Vinai Kumar Dwivedi, Learned District Judge, Muzaffarnagar.

Sir,

I most respectfully beg to submit my representation on the subject noted above as under:

- **1.** That I am an officer of 2018 batch of Civil Judges (Junior Division) who joined judicial service on 20.02.2020.
- **2.** That during the Assessment Year 2023-24, I was posted as Civil Judge (Junior Division)/F.T.C, Muzaffarnagar from 01.05.2023 to 31.03.2024.

- 3. That the learned District Judge, Muzaffarnagar has recorded following appreciative entries in my ACR for the Assessment Year 2023-24 except in relation to the disposal of execution cases: "integrity- beyond doubt, fair & impartial in dealing with the public & bar, cool minded. there nothing adverse against my private character, fixing of cause list-proper, sufficient number of cases fixed to keep engaged during full court hours, unnecessary adjournments avoided, judgments on facts and on law-sound are on the whole sounded and well reasoned and expressed in good language, marshalling of facts-good, appreciation evidence-proper, application of law- proper, total work done-1361.10 Units against the required units against actual working days 695.36 units 195.74% which is adequate and above the norms, used to grant or refuse interim orders & injunctions for sufficient reasons, control over the office and administrative capacity & tact- good, relation with members of Bar-balanced and cordial, behaviour in relation to brother officers-good, inspections of court & office-full & effective, punctual and regular in sitting on dias during court hours, amenable to the advice of the District Judge & other superior officers, behaviour towards women, respect and sensitivity exhibited towards them-good, state of health-normal, overall assessment of the officer-"Good".
- 4. That the only adverse remark recorded by the said learned District Judge, Muzaffarnagar against me in the Assessment Year 2023-24 is that Out of 10 Execution cases officer has decided 01 Execution case not on merit but otherwise. It is accepted that only 01 execution case has been decided but the case was decided on **merit**. However it is worth mentioning that due to clerical error it has been mentioned as non-contested in the statement attcahed. As far as civil and execution cases are

concerned, the court which has been assigned to me is Crime against Women where primary focus is given on cases which are dealing with crime against women.

**5**. That during the assessment year 2023-24, I disposed of 147 criminal cases and 07 civil cases that were more than 5 years old and 59 criminal cases and 07 civil cases that were more than 10 years old. Regarding the oldest criminal pendency, I disposed of 02 case from 2001, 01 case from 2002, 05 case from 2005, 01 case from 2008, 02 cases from 2009 as till 11/03/2024 I had no pendency before 2000. The pendency was received through transfer on 11/03/2024.

**6.** It is, therefore, humbly prayed that your goodself may kindly place this representation of mine before the then Hon'ble Administrative Judge of the District Court, Muzaffarnagar for his Lordship's kind consideration. It is further prayed that the Hon'ble Court may be pleased to kindly consider this representation of mine and make my proper assessment by expunging the aforesaid only adverse remark on the point of disposal of only 01 execution case as recorded by the learned District Judge, Muzaffarnagar in my ACR for the Assessment Year 2023-24. I shall remain grateful to the Hon'ble Court for this grace throughout my life.
