With due reverence, I beg to submit my representation on the above cited subject:

1. That undersigned is presently posted as Civil Judge (Sr. Div.)/ Fast Track Court, Ramabai Nagar (Kanpur Dehat) from 20.11.2023 to till date. The Annual Confidential Remark for the year 2023-2024 has been recorded by Sri. Jai Prakash Tiwari, Respected District Judge, Ramabai Nagar (Kanpur Dehat).
2. That during the Self Assessment Year 2023-2024, the details of charges held by the undersigned are as under:
 - a). Additional Civil Judge (J.D.)- Court No.-04/J.M., Ramabai Nagar (Kanpur Dehat) from 01.04.2023 to 30.04.2023
 - b). Judicial Magistrate-II, Ramabai Nagar (Kanpur Dehat) from 01.05.2023 to 28.05.2023
 - c). Additional Civil Judge (J.D.)- Court No.-06/J.M., Ramabai Nagar (Kanpur Dehat) from 29.05.2023 to 23.07.2023
 - d). Judicial Magistrate-I, Ramabai Nagar (Kanpur Dehat)/ Principal Magistrate, Juvenile Justice Board from 24.07.2023 to 19.11.2023
 - e). Civil Judge (Sr. Div.)/F.T.C Ramabai Nagar (Kanpur Dehat) from 20.11.2023 to 31.03.2024 (maternity leave period) 03.12.2023 to 30.05.2024)
3. The Annual Confidential Remarks as recorded by respected District Judge are: *"Integrity of the Officer-Beyond doubt, If she/he is fair and impartial in dealing with the public and bar- The officer is fair and*

impartial in dealing with public and bar, If she/he is cool minded and does not loose temper in court- Yes, The officer is cool minded and does not lose temper in court. Proper fixation of cause list- Yes, Fixed cause list properly.

4. That the respected District Judge, without pointing out any specific shortcoming and lapse in the five attached judgments in *column 01(f) of my Annual Confidential remarks has remarked that: "Yes, officer has passed sound and reasoned judgements and expressed in good language."* and in *column 01(f)(i) Marshalling of facts: Very Good, column 01(f)(ii) Appreciation of evidence: Good, column 01(f)(iii) Appreciation of law: Good, column 01(f)(iv) Judgement/Order capability: Very Good.* It is humbly apprised that as a presiding officer of various courts, I had meticulously marshalled the facts of every case and as far as appreciation of evidence and application of law is concerned, relevant case laws had been mentioned while writing judgements and orders. Further, I had also made impartial assessment of the facts of each case adhering principle of natural justice.
5. It is humbly submitted that as a presiding officer during the self assessment period 2023-2024, I have disposed off 2509 total number of Cases. I made an effort to expedite disposal of old cases and 23 disposed Cases were older than year 2000, 19 cases were decided after full contest. During above mentioned period, I was on Maternity leave of 180 days w.e.f. 03.12.2023 to 30.05.2024 and for rest of the period I had attained target units and with utmost zeal and conviction achieved **211.74%** of work done.
6. It is also submitted that I have never earned any displeasure from the respected District Judge, court staff, litigants, police officials and member of Bar Association during the assessment year 2023-2024 while performing official duties. There has never been any complaint by any of the parties or their learned counsel or by anybody else against my administrative capacity. Despite many constraints, I have made efforts to dispose off as many cases as possible and to reduce pendency. I had complied all the directions given by the respected District Judge within stipulated time. Despite that the respected District Judge has assessed my overall merits as 'Good'.


