Subject:- Regarding remark awarded by Hon'ble Administrative Judge Etah in
Annual confidential report for the year 2022-2023.

Sir,

On the above mentioned subject it is submitted with utmost regard that during the persual of my Annual confidential report for year 2023-2024, I came to know that for the assessment year 2022-2023, the Learned District Judge Etah rated me "very good officer" and my integrity was certified. Hon'ble Administrative Judge Etah has also confirmed the remark given by Learned District Judge Etah and rated me overall assessment very good but withhold my integrity with following remark :-

The officer, namely, Shri Kumar Gaurav remained posted as Special Judge (E.C. Act), Etah w.e.f. 01.04.2022 to 04.07.2022 and A.S.J./Special Judge Rape and P.O.C.S.O-II Etah w.e.f. 05.07.2022 to 31.03.2023. The Officer has also remained posted as Incharge of Central Nazarat Office, Office Incharge Litigation, Committee for Security of Court Campus and Residential Building Beautification of Lawns and Campus (Chairman), Vulnerable Witness Deposition Centre Committee (Chairman), Purchase Committee(Member) and State Court Management System Committee (Member). Total units achieved by him in the assessment year in question were 2590.51. The Officer has disposed of 195 cases are pertaining to more than five years old category and 22 cases are pertaining to more than ten years old category. He is also stated to be fair and impartial in dealing with public and Members of Bar, cool minded and no incident has been reported to me with regard to loosing his temper in Court. His relation with the officers and Members of Bar were cordial and judgement passed by him also appears to be sound on facts and law and have been expressed in good language. He also appears to be punctual and regular in siting on dais in court and no complaint has been made to me about his

work, conduct and integrity. His is also amenable to the advice of the District Judge. The District Judge has assessed the overall performance of the officer as 'Very Good'.

Keeping in view the performance in the year under reporting, his overall assessment is assessed as 'Very Good'.

A vigilance enquiry is shown to be pending against the Officer. His integrity for the year under reporting would be subject to the outcome of Vigilance Enquiry No. 14 of 2022.

In this regard it is most respectfully submitted that neither any Vigilance enquiry has been initiated against me nor I have ever been informed by the Hon'ble Court regarding any Vigilance enquiry is being pending against me during my Service, It is further humbly submitted that so far as the enquiry No. 14 of 2022 is concerned, it has never been initiated against me. Hon'ble Administrative Judge confirming the rating given by Learned District Judge Etah has mentioned that no complained has been made about the work, conduct and integrity of the officer. This adverse remark will ruin my career.

You are, therefore, requested to your good offices to kindly place my representation before the Hon'ble Court for kind perusal and sympathetically consideration for confirming my integrity "Beyond Doubt" for the reporting year 2022-2023. I shall be highly obliged .
