Subject: - Representation for expunging the adverse remark and upgrading the same.

Respected Sir,

In reference to the subject mentioned above, it is my humble submission that-

1- For the year 2023-24, the then Hon'ble Administrative judge has assessed me as "average" on dated 24.06.2024 on the basis of complaint made against me by Madam Shreyasi Pandey and given the following remarks also-

"The officer is Presiding Officer in MACT and posted as such at Gorakhpur Judgeship from 01.04.2023 to 31.03.2024. The officer concerned is akin to the rank of District Judge. I have perused the self-assessment and the judgments annexed. Besides this, I have also received certain complaints against the officer concerned and sought a report therefrom. Keeping in view the nature of allegations made in the complaint is indeed shocking and deserves thorough inquiry into the matter. The allegations is made by some lady by which the officer concerned is seeking certain sexual favours from that lady. This by itself is very unpleasant against the Presiding Officer, MACT. The Court is waiting for the final outcome from the inquiry. But keeping in view the nature of allegations, the remark given to the concerned officer is 'Average'."

2- A copy of the above complaint received by me on 30.07.2024 through the District Judge, Gorakhpur Sh. Tej Pratap Tewari ji for my comments.



3- I have sent my comments on 22.08.2024 through The District Judge, Gorakhpur.

4- In the year 2023-24, it is pertinent to mention here that from 01.04.2023 to 22.11.2023, I was posted at PO. MACT (N), Lucknow and from 23.11.2023 to 31.03.2024, at PO. MACT Gorakhpur.

5- With folded hands, I would like to mention here that I am doing my judicial work keeping in mind "Paramount interest of litigants".

My work done for the year 2023-24 in 259 working days (including several strikes) are as follows: -

- A- 173 Claim Petitions decided on merit,
- B- 450 Claim Petitions decided on compromise,
- C- 18 Claim Petitions decided ex- parte,
- D- 103 Claim Petitions decided non-contested.

Total claim petitions decided are **744** and total Misc. Cases decided are **1277**.

In the year 2023-24, I have decided the following cases under **Action Plan** (required 100 claims on merit) among the above -

- A- 108 Claim Petitions decided on merit,
- B- 6 Claim Petitions decided on compromise,
- C- 13 Claim Petitions decided ex- parte,
- D- 38 Claim Petitions decided non-contested.

Total **165** cases are decided which are oldest upto the year 2012.


