May kindly see the online application of Sri Mayank Kumar Jain, District & Sessions Judge, Agra regarding grant of permission to use staff car for undertaking journey from Agra to Gurgaon to & fro for personal use.

In his application, Sri Jain has stated that he desires to proceed for Gurgaon as his daughter has to vacate rented accommodation. To undertake this journey, he desires to use official vehicle no. UP 80/AG-1177. He will pay the expenses as per rule for use of official vehicle. He has, therefore, requested to place his application before the Hon'ble Court for grant of permission to leave the station in the morning of 13.06.2020 and to use official vehicle for the aforesaid journey. In his detailed application under attachment heading 'Granting of permission to use official vehicle for personal use' it is submitted that he has accomplished his journey from Agra to Gurgaon to & fro on 13.06.2020 in official car i.e. Innova Crysta bearing reg. no. UP 80 AG 1177. Since, it was a journey for personal use, the said car has travelled 381 kms. Thus, according to G.O. no.- C.A.-1415/10-2002-Mith-2/2001 dtd. 28.09.2002, the officers are authorized to use official vehicle for 200 kms for personal use of the staff car & if it exceeds, then the concerned officer has to deposit 3 Rs. per kms. to the treasury. In this way, the journey from Agra to Gurgaon to & fro after deducting additional 200 kms, the distance of remaining 181 Kms. @ 3 Rs. per kms. of used fuel is Rs. 543/- along with challan on 25.08.2020 which has been deposited in SBI, Agra. Copy of Challan can be seen as attachment. He has, therefore, requested that Hon'ble Court may kindly be moved to accord him permission for the use of the official vehicle for the above mentioned visit.

In this connection, It is also pertinent to mention here that earlier the officer had submitted his application through offline mode and after asking him to do so through online mode on e-service portal, he has submitted the same on the portal by enclosing copy of his earlier

application as attachment. The date for his visit from Agra to Gurgaon to & fro is passed over & in the meantime the journey has already been performed by the officer as records shows. He has used the official vehicle for his personal journey from Agra to Gurgaon which is in accordance with Rules & the G.O. and has deposited due money, his request to use official vehicle appears to be considerable.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Ved Prakash Vaish, Administrative Judge, Agra Judgeship for His Lordship's kind perusal & orders regarding grant of ex-post facto permission now to use official vehicle by Sri Mayank Kumar Jain, District & Sessions Judge, Agra for the journey mentioned above, as per the provisions of relevant Rules and G.O.?
