May kindly see the online application of Sushri Bharti Tayal, Addl. Civil Judge (Jr. Div.), Bulandshahr regarding grant of permission to do/pursue LL.M. Course through distance learning/correspondence from Kurukshetra University.

In her application, Sushri Bharti has stated that she wishes to add qualification and wants to enroll for LL.M. Distance Learning Programme (2 years) of Kurukshetra University, Kurukshetra and since it is a correspondence course, having annual system of examination, her judicial work will not be hampered. She has also stated that she would not take any study leave for pursuing this course and the academic session of her course is from July 2020-June 2021 for part-I and for part-II its July-2021 to June 2022. She has also declared that this course can be pursued without attending day to day classes. She has also enclosed prospectus and syllabus of LL.M. Course as attachment. She has, therefore, requested for grant of permission to do/ pursue LL.M. Course through distance learning from Kurukshetra University.

In this connection, it is stated that Sushri Bharti has joined the U.P. Nyayik Sewa on 16.12.2019. There is circular letter dated 4.11.11, which provides that if any Judicial Officer during the course of her Service, requests to pursue higher studies, she has to apply for grant of 'Study Leave' as per rules which will be subject to the discretion of Hon'ble the Chief Justice. In the instant case, the officer has stated that she would not take study leave for the said LL.M. Course, her request appears to be considerable. However acceptance of her request is on the discretion of the Court. It is also submitted that a Judicial Officer can be accorded permission to attend academic classes and specialized higher studies in terms of G.O. No.24/1066-Appointment (B) dated 21.08.1967, subject to the following conditions:-

- 1. Government work should not suffer in any way.
- 2. The academic classes, if any are held outside office hours.
- 3. No preferential treatment will be given in the matter of leave postings and transfer.
- 4. The permission can be withdrawn without notice if; it is found at any time that the government servant neglects her normal work or that public work suffers, in any way.

May, therefore, if approved, the instant matter may be laid before the Nominated Judge, Hon'ble Mr. Justice Pritinker Diwaker for His Lordship's kind perusal and if His Lordship approves:-

(a) Sushri Bharti Tayal, Addl. Civil Judge (Jr. Div.), Bulandshahr may be granted permission to do/ pursue the LL.M. Course through distance learning/ correspondence from Kurukshetra University, Kurukshetra, Haryana, for the academic session from 2020- 2022 with exemption of the requirement to take study leave for the same and without entering into the fact whether the University is recognised

by UGC or not as well as without reserving any future claim of the Officer regarding her qualification if the University is not recognised and also subject to the conditions mentioned above.

Or

(b) to pass any other order which His Lordship deem fit and proper .
