

**Joint Registrar (J) (Budget)**

May kindly see the online application of Sushri Richa Kesarwani, Additional Civil Judge (Junior Division), Bhadohi at Gyanpur regarding grant of permission to visit USA to attend her brother's marriage ceremony. The tentative date of her visit is in the month of February 2021 (probable period of stay is one or two months).

In her application, Sushri Kesarwani has stated that she wants to travel abroad (USA) to attend her brother's marriage ceremony. The tentative date of her journey is in the month of February 2021. The estimated cost of the journey will be around 1.5 lakhs (Rs. one lakh fifty thousand ) which will be bore by her from her salaried account (A/C No. 00000020198951314, State Bank Of India). Photocopy of her passport and bank statement of her salaried account is attached along with her application form for kind perusal. She has further stated that by her abroad visit, no dilemma is likely to create before the government of India or government of Uttar Pradesh. She has, therefore, requested to the Hon'ble Court for grant of permission to visit USA to attend her brother's marriage ceremony. The Tentative date of her visit is in the month of February 2021.

She has also made the following declarations of her visit, which are as follows:-

1. That by her abroad visit, no dilemma is likely to create before the Government of India or before the Government of U.P.
2. That such type of request for abroad visit was not refused to her earlier.
3. That she has not visited any foreign country earlier.

She has, therefore, requested for grant of permission to visit USA to attend her brother's marriage ceremony. The tentative date of her visit is in the month of February 2021 (probable period of stay is one or two months).

In this connection, it is submitted that as per reports, no departmental/ vigilance enquiry is pending against Sushri Richa Kesarwani. Permission to visit foreign country is considered vide G.O no. 1/3/98/-Ka Prasko./1999 dated 14.06.1999 and this Court's Circular letter no. 16/ IVf-101/Admin (A) dated 27.05.2017. As per the G.O. and relevant C.L. of the Court, the officer has furnished details of

her USA visit. It is pertinent to mention here that as her visit is in the month of February 2021 i.e. her USA visit includes all official/ working days except Second Saturday and Sunday and its up to the discretion of Hon'ble The Chief Justice and Hon'ble Administrative Judge, Bhadohi at Gyanpur to grant her permission to visit USA in the month of February 2021 seeing the Court's C.L. dated 27.05.2017, approving guidelines that abroad tour by any officer shall not be availed of during working days of the Court or during the period of suspension/departmental proceedings, except in case of medical treatment of himself/herself, spouse or dependent, or in special circumstances and tours which are sponsored and/ or approved by the State/ Central Government during certain fixed span of time and does not fall during vacations. In these eventualities the Judicial Officers shall seek permission before applying for VISA. But as the officer has stated that she wants to visit USA to attend her brother's marriage ceremony, thus the tour of the officer appears to be a personal trip in order to fulfil her family obligations, if His Lordships deem fit and proper, her request may be considered. It is also submitted that vide the aforesaid C.L. date 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble the Chief Justice or any member of the Administrative Committee authorised by the Hon'ble the Chief Justice. Recently vide order dated 19.10.2020, Hon'ble The Chief Justice has nominated Hon'ble Mr. Justice Pritinker Diwaker for the purpose.

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Bhadohi at Gyanpur Judgeship for kind perusal and orders and if His Lordship approves:-

(a) Sushri Richa Kesarwani, Additional Civil Judge (Junior Division), Bhadohi at Gyanpur may be granted permission, to visit USA to attend her brother's marriage ceremony, the tentative date of visit is in the month of February 2021 (probable period of stay is one or two months) as requested, subject to approval by Hon'ble Mr. Justice Pritinker Diwaker, Nominated Judge for the purpose as per Court's C.L. dated 27.05.2017 and as per recent order dated 19.10.2020 regarding nomination of Hon'ble Mr. Justice Pritinker Diwaker, as mentioned

above, with the condition that proper charge of Government records or cash, if any, or any government property with her, may be handed over by her before proceeding abroad?
