

## **Joint Registrar (J) (Budget)**

May kindly see the online application of Smt. Mahima Jain, Additional Civil Judge (Junior Division), Gautam Budh Nagar regarding grant of permission to visit Dubai during winter vacations i.e. from 25<sup>th</sup> December to 29<sup>th</sup> December 2020 along with her husband.

In her letter, Smt. Jain has stated that she wants to travel abroad (Dubai) during winter vacations i.e. from 25<sup>th</sup> December to 29<sup>th</sup> December 2020 for a period of 5 days, the estimated cost of the journey will be around Rs. 70,000 which will be borne by her, from her salaried account. Photocopy of her passport, official id and bank statement of her salaried account is attached along with her application form for kind perusal.

She has also made the following declarations of her visit, which are as follows:-

1. That by her abroad visit, no dilemma is likely to create before the Government of India or before the Government of Uttar Pradesh.
2. That such type of request for abroad visit was not refused to her earlier.
3. That she has visited Singapore and Mauritius before joining the service.

She has, therefore, requested for grant of permission to visit Dubai during winter vacation i.e. from 25<sup>th</sup> December to 29<sup>th</sup> December 2020 along with her husband.

In this connection, it is submitted that as per reports, no departmental/ vigilance enquiry is pending against Smt. Mahima Jain. Permission to visit foreign country is considered vide G.O no. 1/3/98/-Ka Prasko./1999 dated 14.06.1999 and this Court's Circular letter no. 16/ IVf-101/Admin (A) dated 27.05.2017. As per the G.O. and relevant C.L. of the Court, the officer has furnished details of her Dubai visit. It is pertinent to mention here that as the officer has stated that her visit falls during winter vacation i.e. in the month of December 2020, seeing the Court's C.L. dated 27.05.2017, approving guidelines that abroad tour by any officer shall not be availed during working days of the Court or during the period of suspension/departmental proceedings, except in case of medical treatment of himself/herself, spouse or dependent, or in special circumstances and tours which are sponsored and/or approved by the State/Central Government during certain fixed span of time and does not fall during vacations. In these eventualities the Judicial Officers shall seek permission before applying for VISA. As the tour of the officer appears to be a personal trip and also falls during winter vacation in the month of December 2020, if His Lordship deem fit and proper, her request may be considered. It has been provided that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble The Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or in the District on any deputation post, subject to approval by Hon'ble The Chief Justice or any other member of the Administrative Committee authorized by Hon'ble The Chief Justice. Recently vide order dated 19.10.2020, Hon'ble The Chief Justice has nominated Hon'ble Mr. Justice Pritinker Diwaker for the purpose.

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Ramesh Sinha, Administrative Judge, Gautam Budh Nagar Judgeship for kind perusal and orders and if His Lordship approves:-

(a) Smt. Mahima Jain, Additional Civil Judge (Junior Division), Gautam Budh Nagar may be granted permission to visit Dubai during winter vacations from 25<sup>th</sup> December to 29<sup>th</sup> December 2020 along with her husband as requested, subject to approval by Hon'ble Mr. Justice Pritinker Diwaker, Nominated Judge for the purpose as per Court's C.L. dated 27.05.2017 and as per recent order dated 19.10.2020 regarding nomination of Hon'ble Mr. Justice Pritinker Diwaker, as mentioned above, with the condition that proper charge of Government records or cash, if any, or any government property with her, may be handed over by her before proceeding abroad?
