May kindly see letter dated 31.10.2020 alongwith attested copies of mark-sheets (both years) and degree of LL.M (**online attached on 07.01.2021**) of Sri Abhishek Sharma, Addl. Civil Judge (Junior Div.), Mathura, requesting for inclusion of LL.M qualification in his service-records.

Sri Abhishek Sharma, aforesaid, had earlier requested for grant of Three Advance Increments vide District Judge, Mathura, endorsement no. 517/l dated 04.03.2020 (**offline mode**). Additionally, he has uploaded **self attested photocopies** of Degree and mark-sheets of LL.M. qualification in online mode through eServicesJO portal, accompanied with prayer for inclusion of the same in his service-records (**online attached on 31.10.2020**). Thereafter, he has uploaded attested photocopies of mark-sheets and LL.M degree on 07.01.2021 (**online attached on 07.01.2021**) in response to this courts note dated 18.12.2020.

In this context, it is submitted that Sri Abhishek Sharma, aforesaid, joined U.P.Judicial Services on 24.12.2019 as Addl. Civil Judge (Junior Div.), Mathura. Besides, as apparent from submitted attested copies of mark-sheets and degree of LL.M(**online attached on 07.01.2021**), Sri Abhishek Sharma, completed LL.M course in year 2019 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 30.11.2019. Nevertheless, relevant detail about course completion is not mentioned in his application form of U.P.Nyayik Sewa/UPHJS, thus, said qualification is required to be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sri Abhishek Sharma, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 31.10.2020 (**online attached on 31.10.2020**) of Sri Abhishek Sharma, Addl. Civil Judge (Junior Div.), Mathura, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Mathura, for kind perusal and order to the effect that copy of aforesaid letter dated 31.10.2020 along with attested copies of mark-sheet and degree of LL.M. (**online attached on 07.01.2021**) as well as attested copy of form of U.P.Nyayik Sewa of Sri Abhishek Kumar, Addl. Civil

Judge (Junior Div.), Mathura, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
