

**Joint Registrar(J)(Budget)**

May kindly see letter dated 06.11.2020 (**Online attached on 06.11.2020**) alongwith attested copies of mark-sheets(all semesters/years) and degree of LL.M (**online attached on 06.11.2020 at SL No. 02**) of Sushri Akansha Bansal, Civil Judge (Jr. Div.) Etah, requesting for inclusion of LL.M qualification in her service-records and subsequent grant of three advance increments.

Sushri Akansha Bansal, aforesaid, had earlier requested for inclusion of LL.M. Qualification in her service records on 06.11.2020 uploading attested copies of marksheets and Degree of LL.M. Qualification (**Online attached on 06.11.2020 at SL No. 02**). She has also submitted her representation accompanied with prayer for inclusion of LL.M qualification in her service-records and subsequent grant of three advance increments (**online attached on 06.11.2020 at SL No. 02**).

In this context, it is submitted that Sushri Akansha Bansal, aforesaid, joined U.P. Judicial Services on 14.06.2018 as Addl. Civil Judge (Junior Div.), Etah. Besides, as apparent from submitted attested copies of mark-sheets and degree of LL.M (**online attached on 06.11.2020 at SL No. 02**), Sushri Akansha Bansal, completed LL.M course in year 2016 and was subsequently awarded Degree from University of Delhi, Delhi on 18.11.2017. Nevertheless, relevant details about course completion were not mentioned in her application form of U.P. Nyayik Sewa, thus, said qualification is required to be included in her service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sushri Akansha Bansal, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 06.11.2020 (**Online attached on 06.11.2020**) of Sushri Akansha Bansal, Civil Judge (Jr. Div.) Etah, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Anjani Kumar Mishra, Administrative Judge, Etah, for kind perusal and order to the effect that copy of aforesaid letter dated 06.11.2020 (**Online attached on**

06.11.2020) along with attested copies of mark-sheets and degree of LL.M. (online attached on 06.11.2020 at SL No. 02) as well as attested copy of form of U.P.Nyayik Sewa of Sushri Akansha Bansal, Civil Judge (Jr. Div.) Etah, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
