May kindly see letter dated 09.11.2020 (**Online attached on 09.11.2020 at SL No. 01**) alongwith attested copies of mark-sheets(all semesters/years) and degree of LL.M (**online attached on 09.11.2020 at SL No. 02**) of Sri Abhishek Tripathi, Judicial Magistrate, Mahoba requesting for inclusion of LL.M qualification in his service-records and subsequent grant of three advance increments.

Sri Abhishek Tripathi, aforesaid, had earlier requested for inclusion of LL.M. Qualification in his service records vide his letter dated 12.12.2019 bearing District Judge Mahoba endorsement No. 2359/I.19 dated 16.12.2019 (**Offline**). Thereafter, He was requested to submit attested copies of mark-sheets and Degree of LL.M. Qualification accompanied with prayer for inclusion of the same in his service records vide Hon'ble courts endorsement No. 6633/IV-4823/Admin. (A1) dated 24.08.2020 (**Offline**). Now, he has uploaded relevant LL.M. Credentials on 09.11.2020. (**Online attached at SL No. 02**) accompanied with prayer for inclusion of LL.M qualification in his service-records and subsequent grant of three advance increments (**online attached on 09.11.2020 at SL No. 01**).

In this context, it is submitted that Sri Abhishek Tripathi, aforesaid, joined U.P.Judicial Services on 16.11.2019 as Judicial Magistrate, Mahoba. Besides, as apparent from submitted attested copies of mark-sheets and degree of LL.M (**online attached on 09.11.2020 at SL No. 02**), Sri Abhishek Tripathi completed LL.M course in year 2019 and was subsequently awarded Degree from University of Allahabad, Prayagraj on 11.10.2019. Nevertheless, relevant detail about course completion is not mentioned in his application form of U.P.Nyayik Sewa, thus, said qualification is required to be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sri Abhishek Tripathi, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 09.11.2020 (**Online attached on 09.11.2020 at SL No. 01**) of Sri Abhishek Tripathi, Judicial Magistrate, Mahoba may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Vivek Kumar Birla, Administrative Judge, Mahoba, for kind perusal and if His Lordship approves for

order to the effect that copy of aforesaid letter dated 09.11.2020 (**Online attached on 09.11.2020 at SL No. 01**) along with attested copies of mark-sheets and degree of LL.M. (**online attached on 09.11.2020 at SL No. 02**) as well as attested copy of form of U.P.Nyayik Sewa of Sri Abhishek Tripathi, Judicial Magistrate, Mahoba, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
