May kindly see the above online application of Sri Sumit Gupta, Addl. Civil Judge (Junior Division), Ballia regarding grant of permission to appear in 4th semester examination of LL.M. Course of Banaras Hindu University in order to complete the course.

In his application, Sri Gupta has stated that prior to his joining in U.P. Judicial Service on 16.12.2019, he had given examination of three semesters of said course and only 4th semester examination is left. In 4th semester, he has to clear one paper (Judicial Process) and has to submit his dissertation only. In said LL.M. course, his enrollment no. is 382116 and Roll no. is 18425LLM045. Due to Covid-19 there is no requirement of minimum attendance for 4th semester. Till now, he has not appeared in the examination and has not submitted his dissertation. He has, therefore, requested for grant of permission to appear in 4th semester examination of said LL.M. Course and to submit his dissertation.

In this connection, it is stated that Sri Gupta has joined the U.P. Nyayik Sewa on 16.12.2019. In the instant case, the officer has stated that he had already enrolled for the regular academic course since before joining the Judicial Service and has already given examination of three semesters of said course and only 4th semester examination is left. In order to complete his said LL.M Course, he has to appear in 4th semester examination to clear one paper (Judicial Process) and to submit his dissertation only. It is also submitted that a Judicial Officer can be granted permission to attend academic classes and specialized higher studies in terms of G.O..No.24/1066-Appointment (B) dated 21.08.1967, subject to the following conditions:-

1. *Government work should not suffer in any way.*

2. *The academic classes, if any are held outside office hours.*
3. *No preferential treatment will be given in the matter of leave postings and transfer.*
4. *The permission can be withdrawn without notice if; it is found at any time that the government servant neglects his normal work or that public work suffers, in any way.*

May, therefore, if approved, the file may be laid before Hon'ble Mr. Justice Pritinker Diwaker, Nominated Judge for the purpose, for His Lordship's kind perusal and if His Lordship approves :-

(a) Sri Sumit Gupta, Addl. Civil Judge (Junior Division), Ballia be granted permission to appear in 4th semester examination of LL.M. Course of Banaras Hindu University and to submit his dissertation for the course, in order to complete the course, subject to above mentioned conditions ?

Or

(b) to pass any other order, which His Lordship deem fit and proper.
